Chairman's Statement

Ráiteas an Chathaoirligh



During 2008 a very significant milestone in the history of the National Lottery was reached when the cumulative funds raised for Good Causes since Ireland's National Lottery was first established in 1987 exceeded €3 billion. The actual amount raised in 2008 was €267.8 million, up from €245.5 million in 2007. This brought the total raised to €3,178 million – a very sizeable sum to have generated for Good Causes. When you consider that this money has been allocated by the Government, over the last 21 years, to worthwhile projects in the areas of Youth, Sports and Amenities; Health & Welfare; Arts, Culture & National Heritage, and the Irish Language, the ongoing positive impact of the National Lottery on local communities throughout Ireland can really be appreciated.

B'é €267.8 milliún an tsuim a gnóthaíodh i 2008, ar ardú í ó €245.5 i 2007. D'fhág sé seo gur tuilleadh móriomlán de €3,178 milliún – suim shuntasach gnóthaithe do Dhea-Chúiseanna. Nuair a chuirtear san áireamh gur leithdháil an Rialtas an t-airgead seo, le 21 bliana anuas, ar thionscadail fhiúntacha i réimsí na hÓige, Spóirt agus Áiseanna; Sláinte agus Leasa Shóisialaigh; na nEalaíon, an Chultúir is na hOidhreacht Náisiúnta, agus na Gaeilge, is féidir éifeacht dhearfach leanúnach an Chrannchuir Náisiúnta ar phobail áitiúla a mheas i gceart.

The record level of funds raised in 2008 was made possible by another year of strong growth. Sales increased by 7.9% to €840.1 million, up from €778.5 million in the previous year. This was the third consecutive year of development for the business and gives us an average annual growth rate of 10.9% since 2006.

This level of growth is even more noteworthy as it was achieved while introducing a major re-branding project, encompassing the National Lottery and all its products, and launching two completely new games. The two new games, Millionaire Raffle and Monday Million, were introduced as part of our game innovation strategy and we are very satisfied with our players' level of participation in these exciting games.

The main driver of the overall sales growth in 2008 was the successful performance of Lotto and the related Lotto Plus game during the year. Lotto sales were up by 6.6% to €381.4 million, while Lotto Plus sales increased from €100.1 million in 2007 to €109 million. A major contributing factor to these record levels of Lotto sales was the high number of large jackpots, including the biggest ever Lotto jackpot of almost €19 million, which was won by a syndicate of 16 players from Co Carlow in June.

In its first full year, EuroMillions Plus performed very well with sales of €33.1 million, up from €16.4 million in 2007, while sales of the main EuroMillions game were €109 million.

The steady increase in sales of National Lottery Scratch Card games continued in 2008 with a 5.8% increase to €170.2 million, while sales of our popular niche game, TellyBingo, also increased slightly to €13.9 million.

A total of €455 million was won by players in prizes, up €34.1 million, or 8.1%, from the previous year. Our strategy of making prize levels and opportunities more attractive to players has proven very successful and contributed to the record level of sales. 67% of all adults now play National Lottery games on a regular basis.

I am happy to report that operating costs for 2008, at 14% of sales, were down from 14.4% in the previous year. €94.5 million of these costs are directly related to sales and reflect the increased volume of business. Our 3,675 agents throughout the country received €52.3 million in commission and bonuses, while other costs of sales amounted to €42.3 million. Administration costs, at €19.8 million, accounted for 2.4% of sales, consistent with the previous year.

During 2008, the National Lottery continued to develop socially responsible business practices for the organisation. We are implementing our Responsible Gaming Policy based on the World Lottery Association's Responsible Gaming Principles.

The National Lottery's management team, its employees and its retail agents deserve particular recognition for the level of achievement attained in what was the busiest year yet in the history of the National Lottery. Their loyalty and commitment, as ever more ambitious targets were met, is commendable.

I would like to thank our regulator, the Minister for Finance, Brian Lenihan TD, his predecessor in the role, An Taoiseach, Brian Cowen TD, and the Department of Finance. Together with our other shareholder, An Post, they provided valuable support throughout the year. Thanks also to my Board colleagues whose valued wisdom and expertise was of great benefit to the Company.

Despite the uncertainty of the current economic environment, our vision for the National Lottery remains unchanged. We will continue to provide exciting and entertaining games for our players and, in doing so, we are confident that we will contribute strongly to Irish society. Our focus will be on increasing the funds for Good Causes through the ongoing development, innovation and growth of the business.

B'fhéidir an sár-leibhéal cistíochta i 2008 a bhaint amach i ngeall ar bhliain eile d'fhás neartmhar. Bhí méadú 7.9% ar an díolachán go dtí €840.1 milliún ó €778.5 milliún sa bhliain roimhe sin. B'í seo an tríú bliain forbartha as a chéile don ghnó, rud a fhágann go bhfuil ráta fáis bliantúil de 10.9% againn ó 2006 i leith.

Is suntasaí fós an leibhéal seo fáis nuair a chuimhnítear gur baineadh amach é an fhaid is a bhí tionscadal mór ath-bhrandála idir lámha, ar a n-áirítear an Crannchur Náisiúnta agus a chuid táirgí uile, agus dhá chluiche úrnuá á seoladh. Tógadh isteach an dá chluiche nua, Millionaire Raffle agus Monday Million, mar chuid d'ár straitéis nuálaíochta cluichí agus bhíomar lánsásta le leibhéal rannpháirtíochta ár n-imreoirí sna cluichí spreagúla seo.

Sár-fheidhmíocht Lotto agus a chluiche gaolmhar, Lotto Plus, ba chionsiocráil leis an bhfás iomlán a tháinig ar an díolachán le linn na bliana 2008. Tháinig méadú 6.6% ar dhíolachán Lotto go dtí €381.4 milliún agus d'fhás Lotto Plus ó €100.1 milliún i 2007 go dtí €109 milliún. Cúis mhór leis na sár-leibhéil seo díolacháin ba ea líon mór na n-ollduaiseanna, ar a n-áirítear an ollduais Lotto ba mhó riamh de beagnach €19 milliún, a bhuaigh sindeacáit de shé dhuine déag ó Cho. Cheatharlach mí an Mheithimh.

D'fheidhmigh EuroMillions Plus go sár-mhaith ina chéad bhliain iomlán, agus díolachán de €33.1 milliún aige, ar méadú é ó €16.4 milliún i 2007. Bhí díolachán de €109 milliún ar an bpríomh-chluiche EuroMillions.

Lean an fás seasmhach ar chluichí Scríobchátaí an Chrannchuir Náisiúnta le méadú 5.8% go dtí €170.2 milliún an fhaid is a tháinig fás beag go dtí €13.9 milliún ar ár gcluiche nideoige móréilimh, TellyBingo.

Bhuaigh imreoirí iomlán de €455 milliún, méadú €34.1 milliún nó 8.1% ón mbliain roimhe sin. Bhí rath ar ár straitéis leibhéil agus deiseanna buaite dhuaiséanna a dhéanamh níos tarraingtí do na himreoirí agus chuir sí leis an sár-leibhéal díolacháin. Imríonn 67% de dhaoine fásta cluichí an Chrannchuir Náisiúnta ar bhonn rialta anois.

Is áthas liom a thuairisciú gur thit na costais oibríochta i 2008, arbh ionann iad agus 14% den díolachán, ó 14.4% an bhliain roimhe sin. Tá gaol díreach ag €94.5 milliún de na costais seo le díolachán agus léiríonn siad an méadú a tháinig faoin ngnó. Fuair ár 3,675 gníomhaire ar fud na tíre €52.3 milliún mar choimisiún is mar bhónais agus bhain €42.3 milliún le costais eile díolacháin. B'ionann an €19.8 milliún, a bhain le costais riaracháin, agus 2.4% den díolachán. Bhí sé seo ag teacht le figiúirí na bliana roimhe.

Le linn 2008 lean an Crannchur Náisiúnta de bheith ag forbairt cleachtas gnó a léirigh freagracht sóisialta don eagraíocht. Tá ár bPolasáí Cluichíochta Freagrach, atá bunaithe ar Phrionsabail Cluichíochta Freagracha Chumann Domhanda na gCrannchur (World Lottery Association) á chur i bhfeidhm againn.

Tá aitheantas ar leith tuille ag foireann bainistíochta an Chrannchuir Náisiúnta, ag a cuid fostaithe agus gníomhairí, as an éacht a rinne siad le linn na bliana ba ghnóthaí riamh i stair an Chrannchuir Náisiúnta. Tá ard-mholadh ag dul dá dtiomantas is dá ndílseacht agus spriocanna níos uailimhianaí ná riamh á mbaint amach acu.

Ba mhaith liom buíochas a ghabhail lenár rialtóir, An tAire Airgeadais, Brian Ó Luineacháin TD, leis an té a chuaigh roimhe, Brian Ó Comhain TD, agus leis an Roinn Airgeadais. I dteannta lenár scairshealbhóir eile, An Post, thug siad tacaíocht luachmhar dúinn le linn na bliana. Gabhaim buíochas chomh maith le mo chomhghleacaithe Boird. Chuaigh a ngaos luachmhar agus a saineolas go mór chun tairbhe an Chomhlachta.

In ainneoin na héiginnteachta sa timpeallacht reatha eacnamaíochta, níl aon athrú dultha ar ár bhfís don Chrannchur Náisiúnta. Leanfaimid orainn de bheith ag cur cluichí spreagúla agus taitneamhacha ar fáil dár n-imreoirí, agus tríd sin, beimid ag cur go láidir leis an sochaí Éireannach. Beimid ag díriú ar chur leis na cistí do Dhea-Chúiseanna trí fhorbairt leanúnach, trí nuálaíocht agus le fás ar an ngnó.

Lotto

Lotto sales increased by 6.6% from €357.7 million in 2007 to a record level of €381.4 million in 2008. During the year, a total of €119.6 million was won in Lotto jackpots. In total, 29 new Lotto millionaires were created.

Lotto 5-4-3-2-1

Sales of Lotto 5-4-3-2-1 amounted to €11.2 million, representing a 2.9% increase. With a prize payout level of 66%, Lotto 5-4-3-2-1 continues to provide an attractive option for players. In 2008, players won a total of €7.4 million in prizes.

Millionaire Raffle

The first ever Millionaire Raffle draw took place in August 2008. The draw was limited to 300,000 tickets, which cost €20 each. There were two guaranteed top prizes of €1 million and 530 further prizes at €100,000, €10,000, €5,000, €1,000 and €500 levels. Christina Buckley from Co Kerry became the first millionaire in the Millionaire Raffle game.

EuroMillions

In 2008 overall sales of the EuroMillions game in Ireland were €142.1 million representing an increase of 5.2% on the 2007 figures. Ireland's biggest EuroMillions win in 2008 was a €15 million jackpot sold by Abbey Stores in Carrick-on-Suir, Co Tipperary in July.

EuroMillions Plus sales doubled, up to €33.1 million from €16.4 million in 2007. The game is exclusive to Ireland and gives players the chance to win up to €500,000.

Monday Million

Monday Million launched in September 2008 and generated sales of €6.2 million by the end of the year. With a 55% prize payout, players received €3.4 million in prizes last year. Eileen Farrelly from Co Monaghan won the top prize of €1 million in the first ever Monday Million draw.

During the year, Scratch Card sales grew by 5.8% up to €170.2 million from €160.9 million in 2007. Twenty-four new Scratch Card games were launched in 2008 ranging in price from €1 to €10.

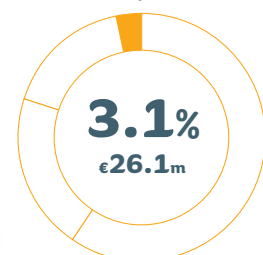

Lotto Plus

The Lotto Plus game recorded strong growth in 2008. Sales increased by 8.8% to €109 million. Twenty-six lucky players won the Lotto Plus 1 top prize of €350,000 and 27 players won the Lotto Plus 2 top prize of €250,000.

TellyBingo

TellyBingo sales increased to €13.9 million in 2008. A total of €9.9 million was won in prizes representing a 71% prize payout. There were 20 snowball winners during the year. The biggest snowball win was €65,000 and the ticket was sold in Dublin.

In the autumn of 2008, an exciting new Winning Streak Dream Ticket Gameshow, hosted by Kathryn Thomas and Aidan Power, was broadcast on national television. On average over €200,000 was won each week on the popular Gameshow. Since the first ever Winning Streak show in 1990, over €107 million has been won by players in cash, cars and holidays.

Together with operating our established games and business, we successfully introduced our new corporate branding and launched a number of new games, including Millionaire Raffle and Monday Million, in the course of the year.

Internet and Mobile Telephone Games

Throughout 2008, the National Lottery continued to develop its platform for internet based games, with a view to offering these games to players at the earliest possible opportunity.

Our plan is to offer players an opportunity to play Lotto, Lotto Plus and EuroMillions via the internet. A specially adapted range of instant win games will also be available on-line.

The National Lottery plans to test market on-line and instant win games in the first quarter of 2009, with a view to rolling all games out to a wider player base during the year.

The overall result at the end of 2008 was an increase in sales of 7.9% to a record €840.1 million; the consequent generation of €267.8 million for Good Causes and the return of €455 million in prizes to players.

I would like to pay tribute to everyone working in the National Lottery and our retail agents throughout the country for the critical role they played in the successful achievement of our ambitious objectives for 2008.

Players

Over 2 million people now play National Lottery games on a regular basis. This figure has increased from 2.1 million to 2.3 million in the past year as more players are attracted to our range of innovative games. We now have six regular draw games, together with our Scratch Card portfolio, TellyBingo and Millionaire Raffle.

On average 81,500 people won National Lottery prizes every day of the year with over €8.7 million distributed in prize money each week. The total amount of prizes distributed in 2008 was up €34.1 million or 8.1% on the previous year.

In 2008 the National Lottery launched the limited edition raffle game – Millionaire Raffle. Christina Buckley from Abbeydorney, Co Kerry became the first Millionaire Raffle millionaire in August. She collected her cheque for €1 million in National Lottery offices with husband Stephen and children Stephanie, Michelle, John and Kate.

For the first time ever, the National Lottery Skyfest spectacular took place outside Dublin. This fantastic firework, lighting and musical display marked the national holiday at the historic Rock of Cashel in Co Tipperary.

Lotto Games

Our core Lotto game continued to capture the imagination of our players during 2008 and again exhibited strong growth, achieving a record level of €381.4 million in sales, up 6.6% from €357.7 million in 2007. The associated Lotto Plus game also performed very well with an 8.8% increase in sales to €109 million. Together these core games account for 58% of total turnover and are the foundation of the National Lottery's success.

€198.3 million in Lotto prizes was won by our players in 2008. During the year there were 40 jackpots of over €5 million; 15 jackpots of over €10 million and four jackpots over €15 million. In total 29 new Lotto millionaires were created.

Youth, Sport, Recreation, Amenities

Ballyfermot Leisure Centre

Ballyfermot Leisure Centre provides sports development, recreation and leisure facilities to the Ballyfermot community and the surrounding areas. The centre's facilities include swimming pool, sauna, steam room, large gym and a full size sports hall for indoor sport, aerobics and spinning studios plus six Five-a-Side all-weather football pitches. It received €250,000 in National Lottery funding last year from the Department of Arts, Sport and Tourism bringing its total funding to €4 million.

In September, George Hook and Teodora Sutra launched the National Lottery's 'George'll Fix It – Bring Dreams To Life' promotion on George Hook's Newstalk radio show. Sponsored by the National Lottery, George made lots of listeners' dreams come true. He paid a listener's mortgage for six months, sent a President Barack Obama fan to Washington and 'fixed it' for one listener to spend a day as a zookeeper in Dublin Zoo.

There were many memorable highlights in the Lotto game during the course of the year. In particular the win of the record €18,963,441 jackpot by the 16-strong Dan Morrissey Syndicate from Carlow in June was fantastic. This is the single biggest prize ever to be collected in the Lotto game since it began in 1988. Other large jackpots in 2008 included a win of €14,543,033 by a group from Co Kildare in March, followed by a win of €15,658,143 by a family from the Clondalkin area in April. Then in August we had another big win when Greg Smyth from Baltray, Co Louth won €9,426,636.

In total €119.6 million was won in Lotto jackpots during the year up from €112.9 million in 2007.

Throughout the year, the excitement of the Lotto jackpots was further enhanced with special promotions. An extra €1 million was added to the jackpot in mid January and again on 15 March to celebrate St Patrick's weekend. As part of our sponsorship of SkyFest 2008 the Lotto draw was broadcast live from Cashel on that night. For both Halloween and Christmas, all Lotto, Lotto Plus 1 and Lotto Plus 2 prizes, excluding the jackpot, were doubled for a week.

Health & Welfare

Samaritans Ireland

Samaritans Ireland provide confidential, non-judgmental emotional support 24 hours a day for people who are experiencing feelings of distress or despair, including those which could lead to suicide. Over 1,400 volunteers in 12 branches across Ireland work together with the shared desire to help people experiencing emotional distress. In 2008, the Samaritans received €200,000 in National Lottery funds through the Department of Health allowing them to upgrade the 24 hour telephone helpline network. With over 230,000 calls in 2008, this funding ensures the system responds efficiently to peaks in demand on the vital 24 hour helpline system and makes the best use of volunteer time.

These special draws and prizes add further to the excitement and fun of the game.

On **Lotto Plus 1** there were 26 winners of the top €350,000 prize, while a further 27 players won the top prize of €250,000 on Lotto Plus 2.

Lotto 5-4-3-2-1 enjoyed a 2.9% increase in sales to €11.2 million. This game provides an important niche offering for those players who enjoy playing this exciting game. Players won a total of €7.4 million in prizes on Lotto 5-4-3-2-1, representing a 66% prize payout.

In September the National Lottery launched its brand new draw game Monday Million. Players who choose six numbers from 1 to 39 have a chance to win €1,000,000 every Monday evening. Eileen Farrelly from Ballybay was the first Monday Million millionaire, taking a cheque for €1,000,000 back to Monaghan in October 2008.

EuroMillions

Overall sales of EuroMillions games were up 5.2% from €135.2 million in 2007 to €142.1 million. Sales in the core **EuroMillions** game were €109 million, despite the lack of significant jackpot rollovers, a decrease of €9.8 million from the previous year. However, this was more than compensated for by a doubling in **EuroMillions Plus** sales which were up to €33.1 million from €16.4 million previously. This game was launched in mid 2007 and is rapidly gaining popularity with players as it gives them an opportunity to win up to €500,000 each week.

Ireland's biggest EuroMillions win during the year was a €15 million jackpot sold at The Abbey Stores, Carrickbeg, Carrick-on-Suir on 4 July. We were delighted to have such a large Irish winner during the year. However, Limerick woman Dolores McNamara remains Europe's biggest ever lottery winner after her €115 million EuroMillions win in 2005.

There was also a lucky €1,084,415 winner of the Match 5 plus 1 Lucky Star from Kerry in October, while 15 Irish players correctly matched five numbers to win the top EuroMillions Plus prize of €500,000 each during the year.

We participated in €130 million EuroMillions Super draws on 8 February and 26 September. There were also EuroMillions Plus Extra draws with top prizes of €500,000 each added on Friday 29 February and Friday 20 June. Then on 31 October, there was a EuroMillions Plus Extra draw with a top prize guaranteed of €1 million.

Overall €72.4 million was won by Irish players in prizes on EuroMillions games during 2008, and more than €45 million was raised for Good Causes in Ireland thanks to players participating in this game.

TellyBingo

Sales of TellyBingo increased to €13.9 million in 2008, up over 1% on the previous year as this TV bingo game continues to prove popular with a loyal group of players. The game has now settled into regular Tuesday and Friday lunchtime slots on RTE television and has a committed following.

The prize payout was an attractive 71%, with a total of €9.9 million paid out to players. There were a total of 20 snowball winners, with the biggest snowball winner of €65,000 sold in Dublin in June.

Scratch Cards

The growth of our Scratch Card business continued in 2008 with a 5.8% increase in sales, up to €170.2 million from €160.9 million in 2007. This €9.3 million increase was achieved as a result of the continued development of our popular game portfolio. During the year we launched 24 new games and had, on average, 12 different games ranging in price from €1 to €10 on offer for players at any one time. We also promoted the use of our Scratch Cards as gifts for special occasions such as birthdays and Christmas, while themed games such as Lucky Dog and Indiana Jones were very popular.

TellyBingo

Scríobcháirtaí

Lean ár ngnó Scríobcháirtaí de bheith ag fás le linn 2008. Bhí méadú 5.8% ar dhíolachán – ardú ó €160.9 milliún i 2007 go dtí €170.2 milliún. Baineadh an t-ardú seo de €9.3 milliún trí fhorbairt leanúnach ar ár bpunann de chluichí móréilimh. Sheolamar 24 cluiche nua le linn na bliana agus ar an meán bhí 12 cluiche difriúil, agus praghsanna ó €1 go €10 an ceann orthu, á thairiscint againn d'imreoirí ag aon am ar leith. Chuireamar ar aghaidh úsáid ár Scríobcháirtaí mar fhéiríní d'ócáidí speisialta dála breithlaethanta agus an Nollaig, agus bhí an-tóir freisin ar chluichí le téama ar leith, dála Lucky Dog agus Indiana Jones.

Irish Language

Logainm.ie

The Placenames Database of Ireland (www.logainm.ie), developed by Fiontar (DCU), contains almost 100,000 placenames in English and almost 70,000 in Irish. The site is widely used by journalists, translators, students and teachers and by people at home and abroad who appreciate the rich heritage of Irish placenames. Many of the placenames are accompanied by scanned archival records. The site also contains a facility to translate lists of placenames to and from Irish. More developments are planned, including a mapping system and educational resources. Visitors to the site can listen to the pronunciation of placenames in a local accent in some of the counties.

Last year, Logainm received over €240,000 in National Lottery funds through the Department of Community, Rural and Gaeltacht Affairs.

The TV Gameshows associated with our '3 star' draw entry Scratch Cards were again very popular with players during 2008. As well as offering hundreds of fabulous cash prizes, the **Big Money** summer game presented by Laura Woods on RTE television offered 39 players and their guests the chance of a lifetime with a trip to Los Angeles and Las Vegas.

In the autumn **Winning Streak Dream Ticket**, an exciting new format for our popular Scratch Card and TV Gameshow, hosted by Kathryn Thomas and Aidan Power was launched. With an average of over €200,000 per week being won on the show, this remains the richest Gameshow in Europe. Winning Streak has given huge prizes and great entertainment to players and television audiences since it began in 1990. A total of over €107 million has been won by players in cash, cars and holidays to date.

Children's Books Ireland

Children's Books Ireland is the national children's book organisation. It is involved in many activities which aim to engage young people with books and create a greater understanding of the importance of books while funding and supporting those with an interest in books for children. Children's Books Ireland is dedicated to ensuring that books are at the centre of young people's lives through resourcing and supporting those who bring children and books together. Last year, Children's Books Ireland received funding of €235,000 from the Arts Council which is part-funded by the National Lottery Beneficiary Fund.

Anuraidh, fuair Leabhair Pháistí Éireann maoiniú de €235,000 ón gComhairle Ealaíon atá páirt-mhaoinithe ó Chiste Thairbhíthe an Chrannchuir Náisiúnta.



Former Miss World and dog lover Rosanna Davison helped to launch the Lucky Dogs Scratch Card in March 2008. Thousands of dog owners from across Ireland hoped their dog would appear on the limited edition Scratch Card. Ten 'lucky dogs' were selected for their 15 minutes of fame.

During the 2008 season 185 players won €9,005,050 in total on the Winning Streak TV Gameshow, with the biggest win going to Helena Freyne from Ballyhaunis, Co Mayo on 12 April when she won €114,500 on the show.

On the Big Money Game winnings of €3,038,250 were shared among 65 players and the biggest winner here was Antaine O'Fearghail from Co. Tyrone who won €285,250 on 16 August.

Holidays and cars continued as popular additional prizes throughout the year, with a total of 83 cars and 113 holidays to the value of €2.1 million won by players on the TV shows.

New Game Launches

The launch of two brand new games added to the excitement of the year. In late May we launched the first ever National Lottery **Millionaire Raffle**. This draw was limited to 300,000 tickets at €20 each and had two guaranteed top prizes of €1 million each, together with a further 530 prizes at €100,000; €10,000; €5,000; €1,000 and €500 levels. We were the first lottery in Europe to launch this type of game and its popularity was such that all tickets were sold out three weeks before the closing date. The results of the draw were announced by Derek Mooney on RTE One TV as part of the Rose of Tralee festivities and two new millionaires were created – Christina Buckley from Abbeydorney, Co Kerry and a winner from Clonmel, Co Tipperary who chose to remain anonymous.

The second Millionaire Raffle was launched for the Christmas season. Again it proved hugely popular with all 300,000 tickets selling out by Christmas Eve, a week in advance of the closing date. The draw took place in the early hours of New Year's Day, 2009 and created two new millionaires and hundreds of other prize winners.

Bhí teorainn 300,000 le líon na dticéad ar €20 an ceann agus bhí dhá dhuais ráthaithe de €1 milliún an ceann ann móide 530 duais bhreise ar €100,000; €10,000; €5,000; €1,000 agus €500. Bhíomar ar an gcéad chrannchur san Eoraip chun an cineál seo cluiche a sheoladh agus bhí tóir chomh mór sin air gur díoladh na ticéid uile trí sheachtain roimh dháta a dhúnta. Fógraíodh torthaí an chrannchuir ar theilifís RTÉ a hAon mar chuid d'fhéile Rós Thrá Lí. Rinneadh beirt mhilliúnaí nua – Christina Buckley ó Mhainistir Ó dTorna, Co. Seoladh an dara Millionaire Raffle aimsir na Nollag. Arís eile, bhí an-tóir air agus bhí na ticéid go léir díolta Oíche Nollag, seachtain roimh dháta a dhúnta. Bhí an crannchur ann go moch ar Lá Caille 2009, rinneadh beirt eile mhilliúnaí agus bhí na céadta buaiteoir eile ann.

The second new game launched in 2008 was **Monday Million**. Designed to banish the Monday blues and add some fun to Monday evenings, the format is similar to the Lotto game and gives players the chance to win €1 million for only €1. The draw takes place on Monday evenings live on TV3. Launched in late September, Monday Million generated sales of €6.2 million to the end of the year. Players received €3.4 million in prizes, a 55% prize payout, and there were two winners of the top €1 million prize. The first was Eileen Farrelly from Ballybay Co Monaghan who won on the very first night of the draw and the second Monday Million winner was a family from Kerry who bought their ticket in Guerins Superstores, Listowel, Co Kerry over Christmas.

Operations

I am pleased to report that our operating costs and administrative costs as a percentage of sales continue to decrease. Our total operating costs were €117.3 million or 14% of sales, down from 14.4% in 2007. The main component of this figure is those costs of €94.4 million which directly relate to sales, including agents' commission and bonuses of €52.3 million up 8% from €48.4 million in 2007. Our administrative costs for the year of €19.8 million accounted for 2.4% of sales.

The single biggest operations initiative undertaken during 2008 was the major revitalisation of the National Lottery brand and the introduction of a new, fresh corporate identity across all aspects of the National Lottery including games, retail stores, communications, on our website and on our TV Gameshows.

This followed a review of the National Lottery's corporate identity undertaken as part of a strategic review of the business. After 21 years of successfully raising funds for Good Causes, we wanted to ensure that our image reflects a contemporary and dynamic National Lottery.

As part of the re-branding process, the National Lottery has adopted a master brand strategy, aligning all of its brands together under an overall brand architecture facilitating greater value for marketing spend and ensuring improved standout in the retail stores. As part of the rebranding, we introduced more environmentally friendly signage and point of sale materials throughout our retail agent network.

Big Money Game US trip winners Kenneth Bowers, John Brett and Ray Malone from Waterford enjoyed a glass of champagne on Venice Beach, California with presenter Laura Woods. All three men are double National Lottery winners. Before winning the trip to the US, they had all previously won great cash prizes on National Lottery TV Gameshows.

This major revitalisation of the brand is designed to improve the National Lottery's profile, efficiency and impact at all levels. We are confident that it will strengthen our ability to grow and help raise even more funds for Good Causes in the coming years.

We continued the expansion of our retail network with the addition of 52 new agents. This brings our total network of National Lottery agents to 3,675. During the year we installed a further 216 ticket checkers and will have these machines in over 2,000 outlets by the end of 2009 for the convenience of our players in checking their tickets.

In 2008 we handled more than 272 million individual transactions, an increase of 10% on the previous year, largely within our existing systems. Our staff numbers increased by nine in 2008 reflecting our commitment to growing our business, in particular developing the capability to provide internet based games. Our teams managed more than 500 separate lottery draws, all conducted under independent external supervision by KPMG, to our exacting standards to guarantee fairness and integrity.

In the year under review we continued to develop our corporate social responsibility initiatives. Under our Responsible Gaming Policy the slogan "**Play Responsibly. Play for Fun**" has now been included on all Scratch Cards and will be extended to draw game tickets, play slips, advertising and communications.

Sponsorship

In March we co-operated with the St. Patrick's Festival organisers to present National Lottery Skyfest at the Rock of Cashel, Co. Tipperary. This spectacular fireworks, lighting and musical extravaganza attracted crowds of 40,000 and brought this historic site to life to celebrate Ireland's national holiday. The show was broadcast live on RTE TV allowing hundreds of thousands of viewers to share in the celebration.

We were also delighted to sponsor a special Celebrity Winning Streak Dream Ticket Gameshow on New Year's Eve. This TV Gameshow featured well known personalities Keith Duffy, Rosanna Davison, Bernard Dunne, Brian O'Driscoll and Caroline Morahan who volunteered to participate and won a total of €203,800 in funding for their chosen charities.

Good Causes

2008 marked a special record in terms of the level of funds raised for Good Causes. Our mission is to raise funds for Good Causes on behalf of the Government and we are delighted to have passed the cumulative €3 billion milestone in the past year.

32% of every Euro spent on National Lottery games goes to Good Causes and in the year under review, we generated €267.8 million for projects all over Ireland, projects which strengthen local communities and improve the quality of life for people in many sections of our society.

Over 21 years, the availability of National Lottery funding has supported active citizenship throughout the country and has been a catalyst for many initiatives at community level.

We are conscious that behind each of the individual projects there are people that bring them to life. These are the individuals who work to secure National Lottery funding and motivate others to apply it for the benefit of the community and we would like to thank them for their efforts.

Throughout this report you will see some examples of the type of Good Causes that have recently benefited from National Lottery funding.

The Future

Our objective as we face the future is to continue to provide our players with a broad range of exciting and varied games. This will be achieved both through the promotion of existing games and the development of new games. In this regard, I am happy to report that we commenced a pilot for National Lottery internet based games early in 2009 and plan to make these games more widely available in the coming months.

Our success in developing and promoting games will ensure that we achieve our aim of raising further funds for Good Causes.

Caitear 32% de gach Euro a fhaigheann an Crannchur Náisiúnta ar Dhea-Chúiseanna agus sa bhliain atá faoi chaibidil ghineamar €267.8 milliún do thionscadail ar fud na hÉireann – tionscadail a neartaíonn pobail áitiúla agus a fheabhsaíonn an caighdeán beatha do dhaoine in an-chuid réimsí d'ár sochaí.

Le 21 bliain anuas tá cistíocht ón gCrannchur Náisiúnta tar éis tacú le saoránacht ghníomhach ar fud na tíre agus ba chatalaíoch í i gcás mórán tionscnamh ar leibhéal an phobail.



Report of the Directors

Tuarascáil na Stiúrthóirí

The Directors have pleasure in submitting their twenty second annual report, together with the audited financial statements of the Company, for the year ended 31 December 2008, in fulfilment of their obligations under the Companies Acts, 1963 to 2006.

1. The Company

The Company carries on the business of operating the National Lottery under Licence from the Minister for Finance in accordance with the provisions of the National Lottery Act, 1986.

80% of the issued share capital is held by An Post and 20% is held by the Minister for Finance.

2. Results for the Year

The results for the year are set out on page 40.

3. Business Review

The information required by Section 13 of the Companies (Amendment) Act, 1986, on the development of the business and important events, is included in the Chairman's Statement and Review of Operations on pages 2 to 23. As described therein, the performance of the Company was again very positive with sales growing by 7.9%, in part driven by strong Lotto growth, the introduction of the Monday Million game in 2008 and the full year of EuroMillions Plus.

As a result, €268 million was raised for the Beneficiary Fund in 2008, compared to €245 million in 2007.

In monitoring the Company's performance, the Directors and management have regard to a range of key performance indicators (KPIs).

The above KPIs are within the terms of the Licence to operate the National Lottery.

The key risks and uncertainties facing the future development of the Company include the retention of the Company's licence to operate the National Lottery, the Company's significant reliance upon its IT infrastructure and retailer operations, the impact of general economic factors on the Company and the introduction of new games and channels. The Directors have developed a range of strategies to address these and other risks faced by the Company. The Corporate Governance Statement on page 27 sets out the Company's policies and approach to risks and the related internal control procedures and responsibilities.

4. Directors, Secretary and their interests

The Directors of the Company are appointed by the Minister for Finance for a fixed term, usually three years, and their conditions of appointment and fees are set out in writing.

The terms of office of Donal Connell, James Hyland and Barbara Patton expired on 5 November 2008. Donal Connell and James Hyland were re-appointed from that date and Barbara Patton was re-appointed on 4 December 2008. Oliver Wilkinson was appointed to the Board on 30 May 2008.

The Directors and Secretary who held office at 31 December 2008 had no interest in the shares in, or debentures of, the Company or any Group Company.

5. Employees

The Company and An Post, which provides seconded staff to the Company, are equal opportunities employers. All applications for employment are given full and fair consideration, due regard being given to the aptitude and ability of the individual and the requirements of the position concerned.

All persons are treated on equal terms as regards training, career development and promotion.

The well-being of staff working in the Company is safeguarded through the strict adherence to health and safety standards. The Safety, Health and Welfare at Work Act, 2005 imposes certain requirements in respect of staff and the Company has taken the necessary action to ensure compliance with the Act, including the adoption of a Safety Statement.

6. Corporate Governance

Maintaining high standards of corporate governance continues to be a priority of the Directors of An Post National Lottery Company. The Board has developed its corporate governance policy so as to give effect to the Code of Practice for the Governance of State Bodies issued by the Department of Finance and to apply as appropriate the relevant main and supporting principles of good governance in the 2006 Combined Code issued by the Financial Reporting Council in the UK. While the provisions of the Combined Code are of direct relevance only to listed companies, the Board feels that their application, where appropriate, assists the Company in its compliance with best corporate governance practice.

The Directors are accountable to the shareholders for good corporate governance and this report addresses how the relevant main and supporting principles of the Code of Best Practice for the Governance of State Bodies and the 2006 Combined Code have been applied within An Post National Lottery Company.

The Board

The Company is controlled through its Board of Directors. The Board's main roles are to oversee the operation of the Company, to provide leadership to the Company, to approve the Company's strategic objectives and to ensure that the necessary financial and other resources are made available to enable them to meet those objectives. The Board, which meets monthly during the year, has a schedule of matters reserved for its approval.

The specific responsibilities reserved to the Board include: setting Company strategy and approving an annual budget and medium-term projections; reviewing operational and financial performance; approving major capital expenditure; ensuring compliance with the terms of the licence to operate the National Lottery, reviewing the Company's systems of financial control and risk management; ensuring that appropriate management development and succession plans are in place; reviewing the environmental, health and safety performance of the Company; approving the appointment of the Company Secretary; and ensuring that a satisfactory dialogue takes place with shareholders.

The Board has delegated the following responsibilities to management: the development and recommendation of strategic plans for consideration by the Board that reflect the longer-term objectives and priorities established by the Board; implementation of the strategies and policies of the Company as determined by the Board; monitoring of the operating and financial results against plans and budgets; development of controls over the operation of draws; prioritising the allocation of technical and human resources; and developing and implementing risk management systems.

5. Fostaithe

Fostóirí comhdheise iad an Comhlacht agus An Post, a sholáthraíonn foireann ar shealscarúint don Chomhlacht. Cuirtear gach iarratas ar fhostaíocht san áireamh go hiomlán agus go cothrom agus tugtar aird chuí ar mhianach agus ar chumas an duine agus ar riachtanais an phoist atá i gceist.

Caitear le gach duine ar bhonn cothrom chomh fada is a bhaineann sé le hoiliúint, le forbairt gairme agus le hardú céime a thabhairt.

Déantar cúram de dhea-bhail na foirne, atá ag obair leis an gComhlacht trí chloí go docht le caighdeáin shábháilteachta agus sláinte. Leagann An tAcht um Shábháilteacht, Sláinte agus Leas ag an Obair, 2005, dualgais áirithe i leith na foirne agus tá na céimeanna riachtanacha glactha ag an gComhlacht chun déanamh de réir an Achte. Áirítear orthusan glacadh le Ráiteas Sábháilteachta.

6. Rialachas Corparáide

Tosaíocht é ag Stiúrthóirí Chomhlacht Chrannchur Náisiúnta an Phoist ardchaighdeán rialachais corparáide a choinneáil. D'fhorbair an Bord a pholasáir ar rialachas corparáide le go mbeadh feidhm ag an gCód Sárchleachtas um Rialachas Chomhlachtaí Stáit a d'eisigh an Roinn Airgeadais agus chun feidhm a thabhairt nuair is cuí do phríomhphrionsabail agus do phrionsabail thacaíochta ábhartha um dea-rialachas atá sa Chomhchód a d'eisigh an Financial Reporting Council sa Ríocht Aontaithe i 2006. Siúd is go mbaineann forálacha an Chomhchóid go díreach le cuideachtaí liostáilte amháin, braitheann an Bord go gcuidíonn a bhfeidhmiú mar is cuí leis an gComhlacht chun sár-chleachtas rialachais corparáide a chomhlíonadh.

Tá na Stiúrthóirí freagrach do na scairshealbhóirí as dearialachas corparáide agus pléann an tuarascáil seo leis an tsli inar cuireadh i bhfeidhm na príomhphrionsabail agus na prionsabail thacaíochta ábhartha atá le fáil sa Chód Sárchleachtas um Rialachas Chomhlachtaí Stáit agus i gComhchód 2006 i gcás Chomhlacht Chrannchur Náisiúnta an Phoist.

An Bord

Rialaítear an Comhlacht trína Bhord Stiúrtha. Is iad príomhróil an Bhoird maoirseacht a dhéanamh ar oibríochtaí an Chomhlachta, cinnireacht a sholáthar don Chomhlacht, cuspóirí straitéiseacha an Chomhlachta a fhaomhadh agus deimhin a dhéanamh de go gcuirtear ar fáil na hacmhainní riachtanacha airgeadais agus eile chun gur féidir leo na cuspóirí sin a bhaint amach. Uair sa mhí a thagann an Bord le chéile le linn na bliana. Tá sceideal ábhar atá forchoimeáda le faomhadh ag an mBord.

I measc na sainfhreagrachtaí atá forchoimeáda don Bhord tá: straitéis an Chomhlachta a cheapadh; an buiséid bliantúil agus na réamh-mheastacháin mheántéarmacha a fhaomhadh; feidhmiú oibríoch agus airgeadais a athbhreithniú; mórchaiteachas caipitil a fhaomhadh; deimhin a dhéanamh de go bhfuil téarmaí an cheadúnais chun an Chrannchur Náisiúnta a reáchtáil á gcomhlíonadh; córais an Chomhlachta um rialú airgeadais agus bainistíú riosca a athbhreithniú; deimhin a dhéanamh de go bhfuil pleananna cuí i bhfeidhm chun forbairt agus comharbaíocht na bainistíochta a chinntiú; feidhmiú an Chomhlachta ó thaobh na timpeallachta agus cúrsaí sláinte is sábháilteachta de a athbhreithniú; ceapadh Rúnaí an Chomhlachta a fhaomhadh; deimhin a dhéanamh de go mbíonn idirphlé sásúil ann leis na scairshealbhóirí.

Tá na freagrachtaí seo a leanas tarmilgthe ag an mBord don bhainistíocht: pleananna straitéiseacha, a bheadh ag teacht le cuspóirí agus le tosaíochtaí fadtéarmacha an Bhoird, a fhorbairt agus a mholadh don Bhord le scrúdú; straitéisí agus polasaithe an Chomhlachta, mar atá sonrath ag an mBord, a fheidhmiú; faireachán a dhéanamh ar thorthaí oibríochta agus airgeadais i gcomparáid le pleananna agus le buiséid; córais rialaithe a fhorbairt do réachtáil na gcrannchur, tosaíochtaí a cheapadh do chionroinnt acmhainní teicniúla is daonna; agus córais bainistíochta riosca a cheapadh is a chur i bhfeidhm.

Report of the Directors

Tuarascáil na Stiúrthóirí

The roles of the Chairman and Chief Executive

The Chairman leads the Board in the determination of its strategy and in the achievement of its objectives. The Chairman is responsible for organising the business of the Board, ensuring its effectiveness and setting its agenda. The Chairman facilitates the effective contribution of non-executive Directors and constructive relations between the executive Director and non-executive Directors, ensures that Directors receive accurate, timely and clear information and manages effective communication with shareholders.

The Chief Executive has direct charge of the Company on a day to day basis and is accountable to the Board for the financial and operational performance of the Company.

Senior Independent Director

The Board has considered the matter of designating a recognised senior member other than the Chairman to whom concerns can be conveyed and, in view of the manner of appointment of Directors, the shareholding structure and existing Board procedures, has concluded it is not appropriate in the circumstances.

Directors and Directors' independence

The Board currently comprises the Chairman, five non-executive Directors and the Chief Executive. The names of the Directors together with their biographical details are set out on pages 24 and 25. The positions of Chairman and Chief Executive are held by different persons. Given its status as a State Company, its shareholding structure and the appointment of the Directors by the Minister, the Board believes that the criteria normally used by the Board of a listed Company in considering the independence of its Directors do not apply to the Company. The Board includes independent non-executive Directors who constructively challenge and help develop proposals on strategy, bring strong, independent judgement, knowledge, and experience to the Board's deliberations. The independent Directors are of sufficient calibre and number that their views carry significant weight in the Board's decision making.

The 2006 Combined Code requires the Chairman to hold meetings with the non-executive Directors without the executive Director being present. The Board has formal procedures in place in this regard.

Directors have the right to ensure that any concerns they have, which cannot be resolved, about the running of the Company or a proposed action, are recorded in the Board minutes. In addition, upon resignation, a non-executive Director will be asked to provide a written statement to the Chairman, for circulation to the Board, if they have any such concerns.

The Directors are given access to independent professional advice at the Company's expense, when the Directors deem it is necessary in order for them to carry out their responsibilities.

All of the non-executive Directors are independent of management. The Board includes both the chief executive of the Company's parent company, An Post, as Chairman and James Hyland, a non-executive director of An Post. The Board considers all other non-executive Directors to be independent on the basis of the following:

- they have not been an employee of the Company within the last five years;
- they have no material business relationship with the Company, nor have they had any within the last three years;
- they receive no remuneration other than through Director's fees;
- they have no close family ties with any of the Company's advisers, Directors or senior employees; and
- they hold no cross-directorships and have no significant links with other Directors through involvement in other companies or bodies.

Ról an Chathaoirleach agus an Phríomhfheidhmeannaigh

Is é An Cathaoirleach a threoraíonn an Bord maidir le cinneadh polasaí agus le baint amach a chuid cuspóirí. Is é an Cathaoirleach atá freagrach as gnó an Bhoird a eagrú, as a éifeacht a chinntiú agus as an gclár gnó a shocrú. Éascaíonn an Cathaoirleach rannpháirtíocht éifeachtach na Stiúrthóirí neamh-fheidhmiúcháin agus deachaidreamh idir iad agus an Stiúrthóir feidhmiúcháin agus cinntíonn sé go bhfaigheann na Stiúrthóirí eolas cruinn, tráthúil agus soiléir. Bainistíonn sé freisin cumarsáid éifeachtach leis na scairshealbhóirí.

Is ag an bPríomhfheidhmeannach atá údarás díreach ar an gComhlacht ó lá go chéile agus tá sé freagrach don Bhord as feidhmiú oibríoch agus airgeadais an Chomhlachta.

Stiúrthóir Sínearach Neamhspleách

Scrúdaigh an Bord an fhéidearthacht go gceapfaí comhalta sínearach inaitheanta, seachas an Cathaoirleach, mar dhuine go bhféadfaí ábhair imní a chur faoina bhráid. I ngeall ar an tsli ina gceaptar Stiúrthóirí, struchtúr an scairchaipitil agus gnáthaimh reatha an Bhoird, shocraigh an Bord nach mbeadh a leithéid de shocrú oiriúnach faoi láthair.

Stiúrthóirí agus Neamhspleáchas na Stiúrthóirí

San am i láthair, is iad comhaltaí an Bhoird an Cathaoirleach, cúigear Stiúrthóirí neamh-fheidhmiúcháin agus an Príomhfheidhmeannach. Tá ainmneacha na Stiúrthóirí mar aon le sonraí beathaisnéise orthu leagtha amach ar leathanaigh 24 go 25. Daoine difriúla atá i bpost an Chathaoirleach agus i bpost an Phríomhfheidhmeannaigh. Nuair a chuirtear san áireamh gur comhlacht Stáit atá i gceist, struchtúr an scairchaipitil agus gurb é an tAire a cheapann na Stiúrthóirí, measann an Bord nach dtagann na gnáth-chritéir, a d'úsáidfeadh stiúrthóirí chuideachta liostáilte chun neamhspleáchas a Stiúrthóirí a mheas, i bhfeidhm sa chás seo. Áirítear ar an mBord Stiúrthóirí neamh-fheidhmiúcháin neamhspleácha a cheistíonn ar bhealach dearfach moltaí faoi chúrsaí straitéise agus a chabhraíonn le hiad a fhorbairt. Thairis sin, tugann siad breithiúnas láidir, neamhspleách, maille le heolas agus taithí agus ceisteanna á scrúdú ag an mBord. Tá na Stiúrthóirí neamhspleácha líonmhar a dhóthain agus de chaighdeán sách ard le go mbeadh tionchar nach beag ag a dtuairimí ar chinntí an Bhoird.

Faoi Chomhchód 2006 tá dualgas ar an gCathaoirleach cruinnithe a bheith aige leis na Stiúrthóirí neamh-fheidhmiúcháin gan an Stiúrthóir feidhmiúcháin a bheith i láthair. Tá gnáthaimh fhoirmeálta chuige seo i bhfeidhm ag an mBord.

Tá sé de cheart ag Stiúrthóirí deimhin a dhéanamh de go gcláraítear i miontuairiscí an Bhoird aon ábhar imní gan réiteach atá acu faoi réachtáil an Chomhlachta nó faoi bheart atá molta. De bhreis air sin, iarrfar ar aon Stiúrthóirí neamh-fheidhmiúcháin a éiríonn as oifig, ráiteas a scríbhinn a thabhairt don Chathaoirleach, le cur thart ar an mBord, má tá aon ábhar imní aige.

Cuirtear comhairle neamhspleách phroifisiúnta ar fáil do na Stiúrthóirí ar chostas an Chomhlachta má shíleann na Stiúrthóirí go bhfuil gá lena leithéid le go bhfeadfaidís a gcuid dualgas a chomhlíonadh.

Professional development

On appointment, all new Directors take part in an induction programme when they receive information about the Company, the role of the Board and the matters reserved for its decision, the terms of reference and membership of the principal Board and Board committees, the Company's corporate governance practices and procedures, including the responsibilities delegated to Company senior management, and the latest financial information about the Company. This will typically be supplemented by meetings with key senior executives. Throughout their period in office, the Directors are continually updated on the Company's business, the competitive and regulatory environments in which it operates, corporate social responsibility matters and other changes affecting the Company and the lottery industry as a whole, by written briefings and meetings with senior executives. Directors are also advised on appointment of their legal and other duties and obligations as a Director, both in writing and in face-to-face meetings with the Company Secretary. They are also updated on changes to the legal and governance requirements of the Company and upon themselves as Directors.

Performance evaluation

All Directors are appointed to the Board by the Minister for Finance in accordance with Section 14 of the National Lottery Act, 1986 and their terms of office (generally three years) are set out in writing.

The Board has adopted and performed a formal process for the annual evaluation of the performance of the Board and its principal Committees. The Board considers that the introduction of any further formal evaluation of individual Directors would be inappropriate given the manner of appointment of Directors, the shareholding structure and existing Board procedures.

The Company Secretary

The Company Secretary is a full time employee of the Company's parent company, An Post. The Company Secretary is responsible for advising the Board, through the Chairman, on all governance matters. All Directors have access to the advice and services of the Company Secretary. The Company's Articles of Association provide that the appointment and removal of the Company Secretary is a matter for the full Board.

Information

Regular reports and papers are circulated to the Directors in a timely manner in preparation for Board and Committee meetings. These papers are supplemented by information specifically requested by the Directors from time to time.

The non-executive Directors receive monthly management accounts and regular management reports and information which enables them to scrutinise the Company's and management's performance against agreed objectives.

Relations with shareholders

The Board and management maintain an ongoing dialogue with the Company's shareholders on strategic issues. In addition, under the National Lottery Act, 1986, certain operational matters require the approval of the Minister for Finance in respect of which ongoing contact with the Minister is maintained.

The Chairman gives feedback to the Board on issues raised with him by the shareholders. All Directors normally attend the Annual General Meeting and shareholders are invited to ask questions during the meeting and to meet with Directors after the formal proceedings have ended.

Tá na Stiúrthóirí neamh-fheidhmiúcháin uile neamhspleách ar an mbainistíocht. - nach bhfuil aon ghaol gnó ábhartha acu leis an gComhlacht agus nach raibh aon ghaol den chineál sin acu le trí bliana anuas;
- nach bhfuil aon luach saothair, seachas a dtáillí mar Stiúrthóirí, á fháil acu;
- nach bhfuil aon ghaol gairid clainne acu le haon chomhairleoir, stiúrthóir nó fostaí sinsearach de chuid an Chomhlachta; agus
- nach bhfuil tras-stiúrthóireachtaí acu ná aon cheangal suaithinseach le Stiúrthóirí eile trí chuideachtaí nó comhlachtaí eile.

Forbairt Phroifisiúnta

Ar a gceapadh dóibh glacann na Stiúrthóirí nua go léir páirt i gcúrsa intreorach mar a bhfaigheann siad eolas i dtaobh an Chomhlachta, ar ról an Bhoird agus na nithe atá forchoimeáda dá chinneadh, ar théarmaí tagartha agus ar bhallaíocht an Phríomh-Bhoird agus choistí an Bhoird, ar chleachtas is ar ghnáthaimh rialachais chorparáidigh an Chomhlachta, ina measc na freagrachtaí atá tarmáilte le bainisteoirí sinsearach a Chomhlachta, maille leis an eolas airgeadais is déanaí faoin gComhlacht. De ghnáth, cuirtear leis seo trí chruinnithe le heochair-fheidhmeannaigh sinsearach. Le linn a dtréimhsí oifige coinnítear Stiúrthóirí suas chun dáta ar ghnóthaí an Chomhlachta, ar na tosca iomaíochas agus rialála faoin a bhfuil sé ag gníomhú, ar fhreagracht shóisialta chorparáideach agus ar athruithe eile a bhfuil éifeacht acu ar an gComhlacht agus ar thionscal na gcrannchur ina iomláine. Déantar é seo trí mhionteagasc i scríbhinn agus trí chruinnithe le feidhmeannaigh shinsearach. Arna gceapadh dóibh, cuirtear Stiúrthóirí ar an eolas freisin faoin a gcuid dualgas dlíthiúla agus eile mar Stiúrthóirí. Déantar é seo i scríbhinn agus ag cruinnithe i láthair Rúnaí an Chomhlachta. Coinnítear suas chun dáta iad chomh maith faoi athruithe i riachtanais dlíthiúla agus rialachais an Chomhlachta agus a gcuid féin mar Stiúrthóirí.

Meastóireacht ar Fheidhmiú

Ceapann an tAire Airgeadais na Stiúrthóirí uile ar an mBord faoi réir Alt 14 den Acht um Chrannchur Náisiúnta 1986 agus leagtar amach a dtréimhsí oifige (trí bliana sa ghnáthshlí) i scríbhinn.

Tá glactha ag an mBord le próiseas foirmiúil chun meastóireacht bhliantúil a dhéanamh ar fheidhmiú an Bhoird agus a phríomhchoistí. Tá an Bord den tuairim nach mbeadh aon mheastóireacht fhoirmiúil bhreise ar Stiúrthóirí aonair cuí nuair a chuirtear san áireamh an tslí ina gceaptar Stiúrthóirí, an struchtúr scairseilbhe agus na gnáthaimh atá ag an mBord faoi láthair.

Rúnaí an Chomhlachta

Fostaí lánaimseartha de chuid na máthair-chuideachta, An Post, é Rúnaí an Chomhlachta. Tá Rúnaí an Chomhlachta freagrach as eolas a choinneáil leis an mBord tríd an gCathaoirleach ar gach gnó rialachais. Tá fáil ag na Stiúrthóirí uile ar chomhairle is ar sheirbhísí Rúnaí an Chomhlachta. Faoi réir na nAirteagal Comhlachais is gnó don Bhord ina iomláine é Rúnaí an Chomhlachta a cheapadh is a bhreisdh.

Eolas

Cuirtear tuarascála agus páipéir thart ar na Stiúrthóirí in am tráth do chruinnithe Boid is Coistí. Cuirtear leis na páipéir seo trí eolas ar leith a sholáthar de réir mar a iarrann Stiúrthóirí é ó am go chéile.

Report of the Directors

Tuarascáil na Stiúrthóirí

Internal Control

An ongoing process exists for identifying, evaluating and managing the significant risks faced by the Company. This process, which is based on the Combined Code Guidance for directors issued by the Institute of Chartered Accountants in England and Wales (the Turnbull Guidance), is periodically reviewed by the Directors and has been in place throughout the accounting period and up to the date the financial statements were approved.

In accordance with the guidance of the Turnbull committee, the Directors are responsible for the Company's system of internal control, should set appropriate policies on internal control, should seek regular assurance that will enable them to satisfy themselves that the system is functioning effectively and should ensure that the system of internal control is effective in managing risks in the manner which it has approved. Such a system is designed to manage rather than eliminate business risks and can provide only reasonable rather than absolute assurance against material misstatement or loss.

The Directors have continued to review the effectiveness of the Company's system of financial and non-financial controls, including operational and compliance controls, risk management and the Company's high level internal control arrangements. These reviews have included an assessment of internal controls by management, management assurance of the maintenance of controls, reports from the internal auditor and reports from the external auditor on matters identified in the course of its statutory audit work.

The Company views the careful management of risk as a key management activity. Managing business risk to deliver opportunities is a key element of all activities. This is done using a simple and flexible framework which provides a consistent and sustained way of implementing the Company's values. These business risks, which may be strategic, operational, reputational, financial or environmental, should be understood and visible. The business context determines in each situation the level of acceptable risk and controls.

Management is responsible for the identification and evaluation of significant risks and for the design and implementation of appropriate internal controls. These risks are assessed on an ongoing basis and are derived from a variety of external and internal sources. Management reports regularly to the Board on the key risks inherent in the business and on the way in which these risks are managed. Management also reports to the Board on any significant changes in the Company's business and on any risks associated with such changes. The process used to identify and manage key risks is an integral part of the internal control environment.

Faigheann na Stiúrthóirí neamhfheidhmiúcháin cuntais mhíosúla bainistíochta maille le tuairiscí agus eolas rialta ón mbainistíocht, rud a chuireann ar a gcumas mionscrúdú a dhéanamh ar fheidhmiú na bainistíochta agus an Chomhlachta i gcomparáid le spriocanna aontaithe.

Caidreamh le Scairshealbhóirí

Bíonn idirphlé leanúnach idir an Bord is an bhainistíocht le scairshealbhóirí an Chomhlachta faoi nithe straitéiseacha. Thairis sin, faoin Acht um Chrannchur Náisiúnta 1986, ní mór faomhadh an Aire Airgeadais a fháil do ghnóthaí oibríochta áirithe agus chuige sin coinnítear teagmháil leanúnach leis an Aire.

Tugann an Cathaoirleach aiseolas don Bhord ar cheisteanna a thóg na scairshealbhóirí leis. Is gnách leis na Stiúrthóirí uile freastal ar an gCruinniú Cinnbhliana agus tugtar cuireadh do na scairshealbhóirí ceisteanna a chur le linn an chruinnithe agus casadh ar na Stiúrthóirí nuair a bhíonn deireadh leis na himeachtaí foirmiúla.

Rialú Inmheánach

Tá próiseas leanúnach ann chun na rioscaí suntasacha, a gcaitheann an Comhlacht aghaidh a thabhairt orthu, a aithint, a mheasúnú agus a bhainistiú. Tá an próiseas seo bunaithe ar Threoracha an Chomhchóid do stiúrthóirí a d'eisigh Institiúid na gCuntasóirí Cairte i Sasana agus sa Bhreatain Bheag (Treoracha Turnbull). Athbhreithníonn na Stiúrthóirí iad ó am go chéile agus bhí feidhm leo le linn na tréimhse cuntasáíochta suas go dtí an dáta ar a faomhadh na ráitis airgeadais.

Faoi réir na treorach a thugann coiste Turnbull, tá na Stiúrthóirí freagrach as córas rialaithe inmheánaigh an Chomhlachta. Ba chóir dóibh polasaithe cuí ar rialú inmheánach a shocrú, deimhniú a lorg go rialta a shásóidh iad go bhfuil an córas ag feidhmiú go héifeachtach agus ní mór dóibh a bheith sásta go bhfuil an córas rialaithe inmheánaigh éifeachtach chun rioscaí a bhainistiú ar an dóigh a faomhadh. Ceaptar córas mar seo chun rioscaí gnó a bhainistiú seachas fáil réidh leo agus ní thig leis ach barántas réasúnta, seachas barántas iomlán, a thabhairt in aghaidh aon mhíríteas ábhartha nó cailteanas.

Lean na Stiúrthóirí de bheith ag athbhreithniú éifeacht chóras rialaithe airgeadais agus neamh-airgeadais an Chomhlachta, ina measc rialúcháin oibríoch agus géilliúntais, bainistíocht rioscaí agus socrúithe rialaithe ardleibhéil an Chomhlachta. Mar chuid den athbhreithniú seo rinneadh meastóireacht ar rialúcháin inmheánacha na bainistíochta, ar dheimhniú ón mbainistíocht go leantar den rialú, ar thuairiscí ón iniúchóir inmheánach agus ar thuairiscí ón iniúchóir seachtrach ar chúrsaí a aithníodh agus an obair reachtúil iniúchóireachta ar bun.

Tá an Comhlacht den tuairim gur eochair-ghníomhaíocht de chuid na bainistíochta é bainistiú cáiríseach a dhéanamh ar rioscaí. Buneilimint i ngach gníomhaíocht é rioscaí gnó a bhainistiú chun deiseanna a thapú. Déantar é seo trí úsáid a bhaint as frámaíocht shimplí sholúbtha a chruthaíonn bealach buan agus seasmhach chun luachanna an Chomhlachta a chur i bhfeidhm. Report of the Directors

Tuarascáil na Stiúrthóirí

The key procedures which the Directors have established with a view to providing effective internal control are as follows:

- A clear focus on business objectives as determined by the Board after consideration of the statutory responsibilities and risk profile of the Company's business.
- A defined organisational structure with clear lines of responsibility, delegation of authority and segregation of duties designed to foster a beneficial control environment.
- A risk management process which considers the strategy and development of the business in the context of the annual budget process when financial plans and performance targets are set and reviewed by the Board in light of the Company's overall objectives.
- A report and control system which produces a comprehensive set of financial reports. The annual budget is approved by the Board. Key financial statistics are monitored by management on a daily basis. Actual results are reported monthly against budget and any significant adverse variances are examined and remedial action taken.
- Control procedures – comprehensive procedures manuals are maintained by the Company in respect of all its main activities. In particular, there are clearly defined limits and procedures for financial expenditure, including procurement and capital expenditure, and for all draw operations.
- Monitoring system – compliance with control objectives is monitored on an ongoing basis by management. The control system is also monitored by internal audit whose work is focused on the areas of greatest risk to the Company.

The Company has procedures to ensure that appropriate arrangements are in place for employees to be able to raise, in confidence, matters of possible impropriety, with suitable subsequent follow-up action. Reporting channels have been created whereby perceived wrongdoing may be reported orally and via post, telephone and email, anonymously if preferred.

Directors' remuneration

The remuneration of the Chief Executive is subject to the approval of the Remuneration Committee of the Company. The objective is to maintain the remuneration of the Chief Executive at a level which is attractive to the individual while, at the same time, representing value for money for the Company. A proportion of the Chief Executive's remuneration is performance related and, in this way, is linked to the Company and individual objectives.

Fees for Directors are determined by the Minister for Finance.

No Director has a service contract with the Company.

During the year, the Remuneration Committee comprised Donal Connell, Niamh McGowan and Micheál Ó'Muircheartaigh. Donal Connell acts as Chairman of the Committee. When necessary, non-Committee members are invited to attend. The Committee's principal responsibilities are:

- to determine, on behalf of the Board, the remuneration and other terms and conditions of employment of the Chief Executive;
- to determine, on behalf of the Board, the pay structures and terms and conditions of other senior personnel (as identified by the Chairman of the Board);
- to act, on behalf of the Board, and take all decisions related to pay and pay related matters, as the Chairman of the Board shall determine; and
- to consider any other matters considered by the Committee to be relevant to the foregoing.

The disclosures made in these financial statements relating to Directors' emoluments and pension information are those required under the Irish Companies Acts, 1963 to 2006.

The Audit Committee

During the year, the Audit Committee comprised James Hyland, Niamh McGowan and Micheál Ó'Muircheartaigh. James Hyland acts as Chairman of the Committee. All the members of the Committee are independent non-executive Directors.

Members of the Committee bring to it a wide range of experience from senior positions in business, including that of managing partner of an accounting practice.

Under its terms of reference, the Audit Committee monitors the integrity of the Company's financial statements. The Committee is responsible for monitoring the effectiveness of the external audit process and making recommendations to the Board in relation to the appointment, re-appointment and remuneration of the external auditors. It is responsible for ensuring that an appropriate relationship between the Company and the external auditors is maintained, including reviewing non-audit services and fees. As a result of regulatory or similar requirements, it is necessary to employ the Company's external auditors for certain audit related and non-audit services. In order to maintain the independence of the external auditors, the Committee has determined policies as to what audit related and non-audit services can be provided by the Company's external auditors and the approval process related to these services. In particular, the Board considers it appropriate that independent observer and draw related services, which are the principal constituent of audit related fees paid, be performed by the external auditors. Under these policies, work of a consultancy nature will not be offered to the external auditors unless there are clear efficiencies and value added benefits to the Company while ensuring that the objectivity and independence of the external auditors is maintained. The Committee monitors the level of fees paid to the external auditors.

- considering the adequacy of the Company's system of risk identification and assessment;
- reviewing an annual report on the Company's systems of internal control and its effectiveness, reporting to the Board on the results of the review and receiving regular updates on key risk areas of financial control;

Nomination Committee

As all the authority regarding the appointment of Directors is vested with the Minister for Finance, the matter of constituting a nomination committee is not required to be considered by the Board.

Compliance statement

The Board has developed its corporate governance policy so as to give effect to the Code of Practice for the Governance of State Bodies issued by the Department of Finance and to apply as appropriate the relevant main and supporting principles of good governance in the 2006 Combined Code issued by the Financial Reporting Council in the UK.

Statement of Accounting Policies

For the year ended 31 December 2008

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the Company's financial statements.

1. Basis of Accounting

The financial statements are prepared under the historical cost convention in accordance with applicable law and Irish Generally Accepted Accounting Practice which includes compliance with the financial reporting standards of the UK Accounting Standards Board as promulgated by The Institute of Chartered Accountants in Ireland.

2. Turnover

Turnover from the sale of National Lottery tickets is recognised as the tickets are sold, with adjustments being made for Scratch Card ticket stocks held by agents and for on-line multi draw tickets / advance tickets. Phone Play turnover comprises a portfolio of games where sales are recognised on a draw by draw basis.

All turnover is derived from and originates in Ireland.

3. Prizes

The prize structure complies with the requirements of Section 4(2) of the National Lottery Act, 1986 whereby, taking one year with another, not less than 40% of the total monies received by the Company in respect of the sale of National Lottery tickets shall be distributed in prizes. Prizes are provided for as revenue is recognised on the basis of the game's particular prize structure. Any difference between the total amount provided and the amounts actually distributed is included in Creditors in the balance sheet as a prize liability.

4. Advertising and Promotional Expenditure

Advertising and promotional expenditure is written off in full in the year in which the costs are incurred.

5. Leased Assets - Operating

Operating lease rentals are charged to the Profit and Loss Account on a straight line basis over the lease term.

6. Taxation

The Company is exempt from Corporation Tax under Section 220 Taxes Consolidation Act, 1997.

7. Fixed Assets - Tangible Assets

Tangible assets are shown as having no book value, as the total cost thereof to the Company is reimbursed out of the National Lottery Fund.

Accordingly, no depreciation is provided.

Under Section 17(1) (a) of the National Lottery Act, 1986, the Company holds these assets in trust for the State.

As Éirinn a thagann agus is in Éirinn a fhaightear an láimhdeachas uile.

3. Duaiseanna

Tá an duais-struchtúr ag teacht le forálacha Alt 4(2) den Acht um Chrannchur Náisiúnta 1986. Faoi na forálacha seo, agus bliain amháin á ghlacadh le bliain eile, dáilfear mar dhuaiseanna suim nach lú ná 40% den airgead iomlán a fuair an Comhlacht mar thoradh ar dhíolachán thicéid an Chranchnuir Náisiúnta. 5. Sócmhainní ar léasanna oibriúcháin

Gearrtar costas chíosanna ar léasanna oibriúcháin ar an gCuntas Brabúis agus Caillteanais ar bhonn mhéid chothroim thar tréimhse an léasa.

6. Cánachas

Tá díolúine ag an gComhlacht ó Cháin Chorparáide faoi Alt 220 den Acht Comhdhlúite Cánacha 1997.

7. Sócmhainní Seasta – Sócmhainní Inláimhsithe

Ní léirítear aon leabharluach a bheith ag sócmhainní inláimhsithe ón uair go n-aisíoctar a gcostas iomlán leis an gComhlacht as Ciste an Chranchnuir Náisiúnta.

Dá réir, ní thagann aon mhuirear dímhéasa i gceist.

I gcás na sócmhainní seo, feidhmíonn an Comhlacht mar iontaobhaí thar ceann an Stáit, faoi Alt 17(1) (a) d'Acht um Chrannchur Náisiúnta 1986.

8. Fixed Assets - Financial Assets

Financial fixed assets are shown at cost less provisions for impairments in value. Income from financial fixed assets is recognised in the Profit and Loss Account in the year in which it is receivable.

9. Stocks

Stocks comprise Scratch Card ticket stocks and are valued at cost. Cost includes import duties, V.A.T. and transport costs. All unusable and obsolete stock is written off.

10. Foreign Currencies

Transactions denominated in foreign currencies are translated into Euro and recorded at the rate of exchange ruling at the date of the transaction. Monetary liabilities denominated in foreign currencies are translated into Euro at the rate of exchange ruling at the balance sheet date or at forward purchase contract rates where such contracts exist. All exchange differences are dealt with in the Profit and Loss Account.

11. Pensions

Pensions are provided to seconded staff under multi-employer defined benefit superannuation schemes which are administered by the Company's parent, An Post, and a defined contribution scheme. In relation to the defined contribution scheme, contributions are accrued and recognised in operating profit or loss in the period in which they are earned by the relevant staff.

Due to the seconded nature of staff, the Company is unable to identify its share of the underlying assets and liabilities in the defined benefit scheme which may be attributable to the Company on a consistent and reasonable basis. Because of this, as permitted by FRS 17, the defined benefit schemes are accounted for by the Company as if the schemes were defined contribution schemes.

Déileáiltear le gach difríocht malairte sa Chuntas Brabúis agus Caillteanais.

11. Pinsin

Soláthraíonn an Comhlacht pinsin don fhoireann trí scéimeanna aoisliúntais ilfhostóra le sochar réamh-shainithe a riarann An Post, máthair-chuideachta an Chomhlachta, agus trí scéim ranníochach réamh-shainithe. I dtaca leis an scéim ranníochach réamh-shainithe, fabhraítear na ranníocaíochtaí agus aithnítear iad sa sochar is dochar oibríochta sa tréimhse ina dtuilleann an fhoireann ábhartha iad.

Níl ar chumas an Chomhlachta a chuid de na sócmhainní agus de na dliteanais bhunúsacha sa scéim shocair réamh-shainithe a aithint ar bhonn comhsheasmhach nó réasúnta. 



16. Pensions

The pension entitlements of staff arise under a number of An Post externally funded defined benefit and defined contribution pension schemes, the assets of which are vested in independent trustees appointed by An Post for the sole benefit of employees and their dependants.

An Post operates multi-employer defined benefit schemes. Due to the seconded nature of staff, the Company is unable to identify the share of the underlying assets and liabilities in the schemes, which may be attributable to the Company, on a consistent and reasonable basis. Because of this, as permitted by FRS17, the schemes have been accounted for by the Company as if the schemes were defined contribution schemes.

The valuations of the An Post defined benefit schemes used for the purposes of the FRS17 disclosures have been based on the previous actuarial valuations carried out at 1 January 2005, updated by the independent actuaries in accordance with FRS17 to assess the schemes' liabilities at 31 December 2007. The schemes' assets were stated at their market value at that date. The net pension liabilities of the pension schemes at 31 December 2007, the most recently available information, amounted to €120 million (31 December 2006: €180 million). At 31 December 2007, An Post had 8,181 permanent employees not including the 83 staff of An Post National Lottery Company.

The pension costs of the An Post defined benefit schemes are assessed in accordance with the advice of an independent professionally qualified actuary. The most recent actuarial valuations were carried out at 1 January 2005, using the attained age method and disclosed that the assets of the schemes at that date were sufficient to cover more than 99.9% of the accrued liabilities after allowing for expected future increases in pensionable remuneration.

The principal actuarial assumption was that, over the long term, the annual rate of return on investments would be 2% higher than the annual increase in pensionable remuneration.

Contributions to the defined benefit schemes were at a rate of 14.4% (2007:14.4%) of pensionable remuneration.

The actuarial valuations are not available for public inspection but the results of the valuations have been advised to members of the schemes.

Employer contributions to the defined contribution scheme are at rates varying between 5% and 9% of pensionable remuneration.

The total pension cost in respect of the Company for the year ended 31 December 2008 was €837,000 (2007: €753,000).

An amount of €11,000 is included in accruals (2007: €20,000) representing contributions payable to An Post with respect to the pension schemes at 31 December 2008.

Eascaíonn teidíochtaí pinsin na foirne as roinnt scéimeanna pinsin de chuid An Post, idir cinn le sochar sainnithe agus cinn le ranníocaíocht sainnithe, atá maoinithe go seachtarach, a bhfuil a sócmhainní dílsithe ag An Post le iontaobhaithe neamhspleácha chun leasa na bhfostaithe agus a gcleithiúnaithe agus iadsan amháin.

Riarann An Post scéimeanna il-fhostóra le sochar réamh-shainnithe. Toisc an fhoireann a bheith tugtha ar iasacht, níl ar chumas an Chomhlachta a chuid de na sócmhainní agus de na dliteannais a aithint ar bhonn comhsheasmhach nó réasúnta. Dá réir sin, agus faoi mar a cheadaíonn FRS17, coinneoidh an Comhlacht cuntas ar na scéimeanna amháin is dá mba scéimeanna ranníocaíochta sainnithe iad.

Bunaíodh luachálacha scéimeanna sochar sainithe An Post, chun críche faisnéisithe FRS 17, ar luachálacha achtúireacha a rinneadh roimhe sin ar 1 Eanáir, 2005 agus a thug na hachtúirí neamhspleácha suas chun dáta faoi réir FRS 17 chun measúnú a dhéanamh ar dhliteanas na scéime ar 31 Nollaig 2007. Luadh sócmhainní na scéime ar a luach margaidh ar an dáta sin. B'é €120 milliún glansócmhainní na scéimeanna pinsin ar 31 Nollaig 2007 (31 Nollaig 2006: €180 milliún), an dáta deiridh ar a raibh eolas le fáil. Ar 31 Nollaig 2007 bhí 8,181 buanfhofostáil ag An Post gan 83 fofostáil de chuid Chomhlachta Chrannchuir Náisiúnta An Post a chur san áireamh.

Measúnaítear costais scéimeanna pinsin le sochar sainithe An Post faoi réir chomhairle ó achtúire neamhspleách atá oile go gairmiúil. Rinneadh an luacháil achtúireach dheidh ar 1 Eanáir 2005 agus modh na haoise sroichte á úsáid. Fuarthas amach gur leor na sócmhainní ar an dáta sin chun 99.9% agus breis den dliteanas fabhráithe a chlúdach tar éis soláthar a dhéanamh do arduithe measta i luach saothair inphinsin.

B'é an príomh-bhonn tuiscena achtúireach ná go mbeadh na torthaí a bhainfeadh infheistiúocht amach 2% níos airde ná an méadú bliantúil ar luach saothair inphinsin. Bhí na ranníocaíochtaí do na scéimeanna le sochar réamh-shainnithe ar ráta 14.4% (2007:14.4%) de thuarastal inphinsithe.

Níl fáil ar na luachálacha achtúireacha le go ndéanfaí scrúdú orthu go poiblí ach tá torthaí na luachálacha curtha in iúl do chomhaltaí na scéimeanna.

Is ar rátaí idir 5% agus 9% den tuarastal inphinsinithe atá ranníocaíochtaí na bhfostóirí leis na scéimeanna le ranníocaíochtaí sainnithe.

B'é €837,000 costas iomlán na bpinsean sa bhliain dar críoch 31 Nollaig, 2008 (2007: €753,000).

19. Group Membership and Controlling Party

The Company is a subsidiary undertaking of An Post which holds 80% of the issued share capital.

The sole activity of the Company is the operation of the National Lottery under Licence from the Minister for Finance in accordance with the provisions of the National Lottery Act, 1986. The Licence expires on 31 December 2011. The surplus generated each year is entirely attributable to the National Lottery Fund and, accordingly, the results of the Company are not consolidated within the An Post Group.

The Company was managed and controlled throughout the year by the Directors on behalf of An Post and the ultimate controlling party, the Minister for Finance.

20. Related Party Disclosures

In addition to the secondment of staff working in the Company, undertakings in the An Post Group provide the Company with management and delivery of services. Such services are carried out on an arm's length basis or, where appropriate, in accordance with the terms of the Licence granted by the Minister for Finance to the Company, to operate the National Lottery. An Post also provides agency services to the Company whereby An Post makes sales and pays prizes on behalf of the Company in accordance with the standard terms and conditions and remuneration structure common to all of the Company's agents.

Excluding staff costs (Note 6) and including the Management Fee, expenses for the year in respect of services provided by An Post Group undertakings to the Company amounted to €6,128,000 (2007: €5,586,000).

Amounts due to An Post are set out in Note 12 of the accounts.

The Company's parent, An Post, has agreed to guarantee the performance by the Company of its obligations under the Licence for the holding of the National Lottery granted by the Minister for Finance. An Post has provided the guarantee, the maximum liability of which amounts to €10 million, for the duration of the Licence.

21. Board Approval

The financial statements were approved by the Board of Directors on 17 February 2009.
