### Play the Game

Winning Streak, our longest running Scratch Card game and TV Gameshow, celebrated its 20th anniversary in 2010.

Since it was first broadcast in 1990, over €120 million in prizes of cash, cars and holidays have been given away to thousands of players.

In 2010, 240 players on Winning Streak shared prizes worth €9.9 million, including 77 holidays and 43 cars.

## **Chairman's Statement**

### Ráiteas an Chathaoirligh

---



I am very pleased to report that the National Lottery delivered another good performance in 2010. Notwithstanding the difficulties faced by the Irish economy, we successfully raised a further €243.7 million for distribution by the Government to good causes throughout Ireland.

Is áthas liom a thuairisciú gur fheidhmigh an Crannchur Náisiúnta go maith athuair i 2010. In ainneoin na ndeacrachtaí a bhí sa mhullach ar gheilleagar na hÉireann, d'éirigh linn €243.7 milliún eile a bhailiú le dáileadh ag an Rialtas ar dheachúiseanna ar fud na hÉireann.

The amount raised in 2010 brought the total funds raised since the launch of the National Lottery to over €3.6 billion, with more than €1 billion of that sum raised in the last four years.

2010 was also an excellent year for players as they shared €419.9 million or 54.4% of total sales in prizes, up from 53.8% in the previous year.

### Performance

The experience of lotteries internationally is that as recessionary conditions prevail there is a negative impact on sales. In Ireland, overall turnover in 2010 was down just over 5% in a difficult retail environment. Total sales were €772.0 million compared to €815.1 million in 2009.

Lotto related draw games continued to be the main product category accounting for €430.6 million or 55.8% of sales in 2010. Within this category, Lotto sales were €322.2 million, Lotto Plus sales were €94.3 million and Lotto 5-4-3-2-1 sales increased by 26.0% to €14.1 million.

EuroMillions generated sales of €98.6 million, while the associated EuroMillions Plus game, which is exclusive to Ireland, achieved sales of €33.2 million.

Throughout the year we continued to expand the range of Scratch Card games available. However, sales were affected by the general decline in footfall in retail stores during 2010 and were consequently down to €153.2 million from €163.8 million in the previous year.

Agus an tsuin a bailódh i 2010 tugtha san áireamh, tá os cionn €3.6 billiún bailithe ag an gCrannchur Náisiúnta ó bunaíodh é agus le linn na gceithre bliana seo caite a bhailíodh níos mó ná €1 billiún de.

Ba shár-bhliain í 2010 d'imreoirí chomh maith agus roinneadh €419.9 milliún nó 54.4% den díolachán iomlán orthu mar dhuaiseanna. Méadú é seo ó 53.8% sa bhliain roimhe sin.

### Feidhmíocht

Tá sé mar thaithí ag crannchuir go hidirnáisiúnta go mbíonn éifeacht dhiúltach ar dhíolachán nuair a bhíonn cíulú eacnamaíochta ann. In Éirinn bhí titim de bheagán thar 5% i 2010 ar an láimhdeachas agus an timpeallacht miondíola deacair. Bhí díolachán iomlán de €772.0 milliún ann i gcomparáid le €815.1 milliún i 2009.

Ba chluichí bainteach le Lotto an príomh-chineál táirge agus b'ionann iad is €430.6 milliún nó 55.8% den díolachán i 2010. Taobh istigh den chatagóir seo bhí díolachán de €322.2 milliún ar Lotto, díolachán de €94.3 milliún ar Lotto Plus agus bhí méadú 26.0% ar dhíolachán Lotto 5 4-3-2-1 go dtí €14.1 milliún.

Ghin díolachán ar EuroMillions €98.6 milliún agus bhain an cluiche gaolmhar, EuroMillions Plus, atá eisíach d'Éirinn, amach díolachán de €33.2 milliún.

Le linn na bliana chuireamar le raon na gcluichí scríobchárta a bhfuil fáil orthu. Mar sin féin, chuir an titim ginearálta ar líon na gcustaiméirí i siopaí miondíola le linn 2010 isteach ar an díolachán agus bhí ísliú air, dá réir, ó €163.8 milliún an bhliain roimhe sin go dtí €153.2 milliún.

There was encouraging growth in TellyBingo which, with the addition of a new Thursday draw in September, achieved increased sales of €15.3 million, up 7.2%. The daily game, All or Nothing, also demonstrated strong growth and generated sales of €9.9 million in its first full year.

Total sales of the Monday Million draw game were €20.6 million, with the launch of Monday Million Plus in May generating sales of €3.7 million of this amount.

In 2010, we built on the now well established limited edition raffle game format. First introduced in 2008 with one raffle draw, there were four raffle draws in 2009 as players responded well to the limited edition concept. During the year under review, we had two further millionaire raffles, to coincide with Easter and Christmas. We also introduced the new National Lottery Sweepstakes game giving raffle a new dimension. Together, the three raffle-based games generated sales of €10.6 million in 2010.

Through the ongoing expansion and innovation of its game portfolio, the National Lottery continues to raise excitement levels for players and generate funds for good causes. During 2010, we had a number of significant new game developments. In addition to Sweepstakes, these included the launch of Monday Million Plus and the addition of an extra draw day for TellyBingo.

During the year a total of over 36 million winners shared numerous prizes and promotions across the game portfolio. We had 25 Lotto Jackpot wins, up from 22 in 2009, including two of over €16 million, while in the EuroMillions game, players participated with great excitement in our two €100 million guaranteed superdraws.

## Operations

A continued focus on cost management throughout 2010 resulted in a reduction in total operating expenses from €113.3 million in 2009 to €108.4 million.

Administrative costs, at €19.4 million, were down from €19.7 million in the previous year and accounted for 2.5% of sales, while variable costs of sales, including agents' commission at €48.1 million, were €86.2 million, down from €90.6 million in 2009.

Bhí fás spreagúil faoi TellyBingo, agus le crannchur úr an Déardaoin curtha leis ó mhí Mheán Fómhair, bhain sé amach díolachán de €15.3 milliún, ardú de 7.2%. Léiríodh fás láidir freisin faoin gcluiche laethúil, All or Nothing, agus ghín sé díolachán de €9.9 milliún le linn chéad bhliain iomlán a shaolré.

Bhí díolachán de €20.6 milliún ar an gcluiche crannchuir, Monday Million. Ghin díolachán Monday Millions Plus, a seoladh mí Bealtaine, €3.7 milliún den tsuim seo.

I 2010, thógamar ar fhormáid seanbhunaithe an chluiche crannchuir le ranpháirtíocht teoranta. Tosaíodh air i 2008 le crannchur amháin. Thaitin coincheap na ranpháirtíochta teoranta le himreoirí agus bhí ceithre chranncur ann le linn 2009. Le linn na bliana atá faoi chaibidil bhí dhá chranncur milliúnaí eile againn, um Cháisc is um Nollaig. Thairis sin, thugamar isteach cluiche National Lottery Sweepstakes, rud a thug diminsean nua don chranncur. I bhfochair a chéile, ghín na trí chluiche crannchuir seo díolachán de €10.6 milliún i 2010.

Tríd a phunann cluichí a forbairt is a nuáil, leanann an Crannchur Náisiúnta de bheith ag cothú carabuaice i measc na n imreoirí agus de bheith ag giniúint ciste airgid do dhea-chúiseanna. Le linn 2010 bhí forás suntasach ar chluichí nua. De bhreis ar an Sweepstakes, áirítear orthusan seoladh Monday Million Plus agus lá breise crannchuir do TellyBingo.

Le linn na bliana roinneadh duaiseanna agus promóisín iomadúla thar an phunann cluichí ar bhreis is 36 milliún buaiteoir. Buadh Pota Óir an Lotto 25 uaire – ardú ó 22 bua i 2009 – agus ina measc dhá bhua de bhreis is €16 milliún. Ag an am céanna, ghlac imreoirí sceitimíneacha páirt sa dá ollchranncur ina raibh €100 milliún geallta.

## Oibríochtaí

Díríodh ar bhainistiú costais le linn 2010 ar fad agus bhí mar thoradh air seo gur laghdaíodh na costais oibríochta ó €113.3 milliún i 2009 go dtí €108.4 milliún.

Laghdaíodh na costais riarrachán ó €19.7 milliún sa bhliain roimhe sin go dtí €19.4 milliún. B'ionann iad agus 2.5% den díolachán. €86.2 milliún a bhí ar chostais athraitheacha, €48.1 milliún ar choimisiún na ngníomhairí san áireamh, titim ó €90.6 milliún i 2009.

As part of the National Lottery's retail development policy, we increased our number of retail agents to 3,813, a net increase of 19 locations compared to the previous year. We continued to improve player support across the network with self-service ticket checkers now installed in 89% of all agents.

Throughout the year, the management team and employees worked extremely hard to overcome many business challenges and deliver a strong performance. I would like to thank them all for their efforts, professionalism and commitment.

As chairman, I received much valued support and advice from the National Lottery Board throughout 2010. During the year, Niamh McGowan retired from the Board and I would like to thank her for her contribution over the past 12 years. I am also pleased to welcome Caroline Murphy to the Board.

During the year, the continued support of our shareholders, the Minister for Finance and An Post, was invaluable in our efforts to operate and develop the business.

Whilst the future retail environment in Ireland continues to be uncertain, we believe the ongoing focus on game innovation demonstrated by the National Lottery, together with its commitment to delivering cost efficiencies, will achieve further success in 2011.

I am confident that our strong commitment to the vision, mission and values of the National Lottery will ensure that we continue to raise much needed funds for good causes throughout the country and play an ongoing role in enhancing community life in Ireland.

Mar chuid de pholasáí forbartha miondíola An Chrannchuir Náisiúnta, mhéadaíomar líon na ngníomhairí miondíola go dtí 3,813, ardú glan de 19 ionad i gcomparáid leis an mbliain roimhe sin. Leanamar de bheith ag cothú thacaíocht na n imreoirí trí mheaisíní seiceála féinseirbhise a chur isteach i 89% de na hasraonta.

Le linn na bliana d'oibrigh an fhoireann bainistíochta agus na fostaithe go dian dícheallach chun dúshláin ghnó iomadúla a shárú agus ardleibhéal feidhmíochta a bhaint amach. Ba dheas liom buíochas a ghabháil leo uile as a n iarrachtaí, a ngairmiúlacht agus a dtiomantas.

Mar chathaoirleach, fuair mé an-chuid tacaíochta agus comhairle ó Bhord an Chrannchuir Náisiúnta le linn 2010. D'éirigh Niamh McGowan as an mbord le linn na bliana agus ba mhaith liom buíochas a ghabháil léi as an méid a rinne sí le 12 bliain anuas. Is áthas liom chomh maith fáiltí roimh Caroline Murphy ar an mBord.

Le linn na bliana, bhí tacaíocht leanúnach ár scairshealbhóirí, an tAire Airgeadais agus An Post, fíorluachmhar agus sinn i mbun ár gcuid iarrachtaí chun an gnó a rith is a fhobairt.

Síud is go leanann cúinsí miondíola in Éirinn de bheith éiginnte creidimid go mbeidh rath orainn i 2011 ach leanúint de bheith ag díriú ar nuálaíocht cluichíochta, mar atá léirithe ag an gCrannchuir Náisiúnta, anuas ar a thiomantas chun costais a chiorrú.

Táim deimhin de go gcinnteoidh ár dtiomantas daingean d'fhís, do mhisean agus do luachanna an Chrannchuir Náisiúnta go n éireoidh linn leanúint de bheith ag gnóthú cistí airgid, a bhfuil géarghá leo, do dhea chúiseanna ar fud na tíre agus go leanfaimid lenár ról leanúnach chun saol an phobail in Éirinn a fheabhsú.

## **Review of Operations**

### **Athbhreithniú Oibríochta**

**With sales of €772.0 million and €243.7 million raised for good causes, we delivered another robust performance in 2010. Since 1987, the National Lottery has raised over €3.6 billion for distribution by the Government to good causes throughout Ireland. In the last four years alone, we have generated over €1 billion of that total due to our strong operating performance.**

## HIGHLIGHTS OF THE YEAR BUAICPHOINNTÍ NA BLIANA

In 2010, we faced challenges presented by the ongoing recession, changes in consumers' shopping habits and the effect of the unexpectedly bad weather conditions particularly around the traditionally busy Christmas shopping season.

### Players

Player participation rate remained high with almost two thirds of all adults playing National Lottery games on a regular basis.

Our 2.2 million players shared winnings of €419.9 million across our exciting portfolio of 12 different game categories during 2010. On average, the National Lottery paid out over €1 million every day of the year in tax free winnings to our players.

It was an excellent year for players as the number of jackpot wins was above statistical expectations. In addition to the many large jackpot wins, 897 players won prizes over €10,000.

During the year, we continued our strategy of offering attractive game choices to our players and introduced a number of innovative game developments. These included the launch of Monday Million Plus, the limited edition National Lottery Sweepstakes game and the extension of TellyBingo to three draws per week.

As part of our brand building strategy, a new masterbrand TV advertisement, filmed in Dublin, went on air in August. This attractive advertisement involved hundreds of people in a contemporary Irish setting and brought the 'making magic happen' theme to life as a magical rainbow was created. Its uplifting soundtrack, the Elvis Presley song 'Pocketful of Rainbows,' has become extremely popular with our players.

I 2010 chaitheamar aghaidh a thabhairt ar dhúshláin de dheasca an chúlú leanúnach eacnamaíochta, athruithe ar nósanna siopadóireachta ár gcustaiméirí agus an éifeacht a bhí ag an drochaimsír a tháinig gan choinne le linn tréimhse gnóthach siopadóireachta na Nollag.

### Imreoirí

Lean an ráta rannpháirtíochta de bheith ard agus d'imir nach mór dhá thrian d'aosaigh uile na tíre cluichí an Chrannchuir Náisiúnta ar bhonn rialta.

## Lotto

Lotto related games continue to be a flagship product for the National Lottery accounting for 55.8% of overall sales.

During 2010, Lotto sales were €322.2 million compared to €336.0 million in the previous year.

Players won a total of €161.1 million in Lotto prizes, with great interest and excitement around the two big jackpot wins of the year. Overall, there were 25 Lotto jackpot wins during 2010 creating 23 new individual Lotto millionaires. There were also 172 winners of the Match 5 plus Bonus number prizes.

Throughout the year, the ever popular Lotto game continued to excite players and was further enhanced with a series of special promotions.

€2 million was added to the jackpot in mid-January, leading to a jackpot of €7,457,357 which was collected by Michelle Ryan from Fardrum, Athlone, Co. Westmeath, getting her year off to the perfect start.

For St. Patrick's weekend a further €2 million was added to celebrate National Lottery Skyfest, while a similar amount was added for the Easter weekend jackpot.

In April, the biggest jackpot of the year, and the second largest ever in the history of the Lotto Game, was €16,717,717 million won in Dungarvan, Co. Waterford. We had a special prize promotion for the May Bank Holiday weekend with €2 million added to the jackpot for the Saturday night Lotto draw.

Celebrating its 40th anniversary, the **National Youth Orchestra of Ireland (NYOI)** aims to give its members access to the best possible training and performance experience. Through this, it enhances the lives of young people, enriches cultural life in Ireland through live performances and broadcasts, and cultivates cultural excellence and creativity at home and abroad.

The National Youth Orchestra of Ireland is now annually funded by the National Lottery through the Department of Education and Science and the Arts Council.

Le linn 2010 bhí díolachán de €322.2 milliún ar Lotto le hais €336.0 milliún an bhliain roimhe sin.

Bhuaigh imreoirí iomlán de €161.1 milliún de dhuaiseanna Lotto agus bhí an-spéis agus sceitimíni ag baint leis an dá phota móra óir a buadh le linn na bliana. Ina iomláine, buadh 25 pota óir Lotto le linn 2010 agus rinneadh milliúnaithe de 23 duine. Anuas air sin, bhuaigh 172 duine duaiseanna Match 5 móide duaiseanna uimhreacha bónais.

Le linn na bliana d'éirigh leis an gcluiche mór-thóir Lotto leanúint de bheith ag cur sceitimíni ar imreoirí agus feabhsaíodh é le sraith de phomóisin speisialta.

Cuireadh €2 milliún leis an bpota óir i lár Eanáir, rud a chruthaigh pota óir de €7,457,357, a bhuaigh Michelle Ryan ó Fhardroim, Baile Átha Luain, Co. na hIarmhí. Tús den scoth lena bliain!

Cuireadh €2 milliún eile leis deireadh seachtaine na Féile Pádraig chun Skyfest an Chrannchuir Náisiúnta a cheiliúradh agus cuireadh an tsuim chéanna leis do phota óir na Cásca.

Mí Aibreán, buadh an bpota óir ba mhó le linn na bliana, agus an dara ceann ba mhó i stair an Chluiche Lotto – €16,717,717 milliún – i nDún Garbhán, Co. Phort Láirge. Bhí promóisean duaise ar leith againn do dheireadh seachtaine Shaorlá Bainc na Bealtaine agus cuireadh €2 milliún leis an bpota óir do chrannchur Lotto an tSathairn.



In August, we launched our new style Lotto advertising campaign. Based on the concept ‘*What would you do for a few million euro?*’, it shows characters in a number of humorous situations illustrating the lengths they would go to gain a Lotto jackpot amount.

During September and October, we witnessed the longest Lotto rollover of the year in the build up to the €16,390,239 Lotto jackpot win collected on 27 October by the owner of a ticket bought in Donnybrook Fair, Dublin.

Given that Christmas Day fell on a Saturday in 2010, we held our Lotto draw on Christmas Eve adding €1 million to the jackpot to celebrate the festive season. The resulting €3 million jackpot win proved to be the ultimate Christmas present for a lucky Co. Cork couple who said that the real bonus coming from this win was ‘not having to worry about the day-to-day stuff like the mortgage and the bills’.

### Lotto Plus

Lotto Plus sales were €94.3 million compared to €97.5 million in the previous year. Players shared €45.0 million in prizes, with 25 winners of the €350,000 Lotto Plus 1 top prize and a further 25 winners of the €250,000 Lotto Plus 2 top prize. This total of 50 top prize winners represented a significant increase on the previous year when we had 44 top prize winners in Lotto Plus. More Lotto players than ever now play Lotto Plus as well, with nearly 90% of players playing both games.

Roinneadh luach €45.0 milliún de dhuaiseanna ar imreoirí, bhain 25 buaiteoir an bharr-dhuais Lotto Plus 1 de €350,000 agus bhain 25 buaiteoir eile an bharr-dhuais de €250,000 i Lotto Plus 2. Méadú é an t ionlán seo de 50 buaiteoirí barr-duaise i Lotto Plus ar an 44 buaiteoir barr-duaise an bhliain roimhe sin. Imríonn níos mó imreoirí Lotto ná riamh Lotto Plus agus imríonn beagnach 90% de na himreoirí an dá chluiche.

Players had a special Valentine's treat in February when all winners of Match 5 plus Bonus number prizes also won €100,000 worth of diamonds. There were four such winners on the Lotto Plus games with tickets bought in Kilmacanogue, Co. Wicklow; Ennis, Co. Clare; Clifden, Co. Galway and Mullinahone, Co. Tipperary where the winner was a syndicate of players from Coolmore Stud.

### Lotto 5-4-3-2-1

Lotto 5-4-3-2-1 grew significantly in 2010, with sales up 26.0% to a record €14.1 million from €11.2 million in the previous year, boosted by the full year effect of Lotto 5-4-3-2-1 Plus 1 and Plus 2.

The decision to extend this game to include the Plus draws in 2009, proved popular with players as they continued to show their loyalty to the game format. Prizes won amounted to €9.4 million, or 66.5% of total sales, representing a very favourable return to players.

### EuroMillions

Sales of the mega jackpot EuroMillions game were €98.6 million which represented 12.8% of total sales, compared to the €105.7 million in 2009.

The percentage of EuroMillions players who also play EuroMillions Plus increased from 65% in 2009 to 67% in the course of the year. EuroMillions Plus sales were €33.2 million in 2010.

Over the last few years, the main EuroMillions game has been very popular across the nine participating countries. However, this had an impact on the regularity with which the jackpot was won throughout 2010, resulting in a lack of big jackpot rolls which in turn had an impact on the level of sales.

**An Taibhdhearc** is the National Irish Theatre and stages plays through Irish with a view to enhancing and expanding the use of the Irish language.

Set up by Micheal Mac Liammoir and Hilton Edwards in 1928, An Taibhdhearc has gained a reputation as an artistic centre for the promotion of the Irish language. It has been of immense importance to the city of Galway and the theatre has encouraged those with a love of Irish to use and develop their language skills further.

An Taibhdhearc receives support from the National Lottery through Ciste na Gaeilge.

Thiobraid Árann, áit ar shindecáit ó Coolmore Stud a bhí ina bhuaiteoir.

### Lotto 5-4-3-2-1

Bhí fás suntasach faoi Lotto 5-4-3-2-1 i 2010 agus méadaíodh an díolachán 26.0% go dtí ard-leibhéal de €14.1 milliún i comparáid le €11.2 milliún an bhliain roimhe sin. Bhí éifeacht air seo ag bliain iomlán de Lotto 5-4-3-2-1 Plus 1 agus Plus 2

Thaitin sé le himreoirí gur glacadh an cinneadh i 2009 crannchuir Plus a chur leis an gcluiche agus lean siad de bheith ag léiriú dílseachta d'fhormáid an chluiche. Buadh luach €9.4 milliún de dhuaiseanna arbh ionann iad agus 66.5% den díolachán iomlán. Fáltas fabhrach a bhí anseo d'imreoirí.

### EuroMillions

Bhí díolachán de €98.6 milliún ar chluiche EuroMillions gona phota óir ollmhór i gcomparáid le €105.7 milliún i 2009. B'ionann é seo agus 12.8% den díolachán iomlán.

Mhéadaigh an céatadán d'imreoirí EuroMillions a imríonn EuroMillions Plus chomh maith ó 65% i 2009 go dtí 67% i gcaitheamh na bliana. Bhí díolachán de €33.2 milliún ar EuroMillions Plus i 2010.

Le blianta beaga anuas, bhí an-tóir ar an bpriomh-chluiche EuroMillions sna naoi dtíortha a ghlacann páirt ann. Mar sin féin, bhí éifeacht aige seo ar cé chomh rialta is a buadh an pota óir le linn 2010, rud a d'fhág gur beag tar-rolladh mór a bhí ag an bpota óir. D'fhág an toradh seo a rian ar an leibhéal díolacháin.



There was a €100 million Superdraw in February 2010 which, after a rollover, resulted in €129 million being shared by two winning tickets, one bought in UK and the other in Spain.

Following the offer of another €100 million guaranteed prize in October, the largest single jackpot of the year of €129.8 million was won in the UK on 8 October, 2010. This was Britain's biggest ever EuroMillions winner.

A total of €67.3 million was won by Irish players on EuroMillions and EuroMillions Plus games during 2010. We had as many as 21 players who were just one lucky star number away from winning big jackpots. The highest of these Irish Match 5 plus Lucky Star win was €856,451 in April with a ticket bought in Cushens Good News, Portlaoise.

11 players won the €500,000 top EuroMillions Plus prize. We also had our first big online EuroMillions winner with €632,452 won in September by a Dublin based player.

In the course of the year, there were a number of special EuroMillions promotions including the doubling of all EuroMillions Plus prizes for two draws in April and again in June.

On average, over 37,000 players in Ireland won cash prizes in EuroMillions games each week of the year.

I gcaitheamh na bliana bhí roinnt promóisean speisialta EuroMillions ann, ina measc dúbláil dhuaiseanna EuroMillions Plus do dhá chrannchur mí Aibreáin agus arís mí an Mheithimh.

## Scratch Card Games

Ireland's National Lottery first launched in March 1987 with a Scratch Card game and this category has been an important pillar of our business ever since. Sales of Scratch Card games in 2010 were €153.2 million compared with €163.8 million sales in the previous year. Scratch Cards accounted for 19.8 % of overall turnover, making this product category the second largest after Lotto.

As an impulse purchase, Scratch Card sales were affected by the general reduction in footfall in retail outlets experienced in 2010. This was compounded by the bad weather conditions early in the year and again in December, together with overall changes in consumers' shopping patterns.

Throughout the year, we continued the policy of offering customers a choice of different styles of Scratch Card games for different occasions including Congratulations, Easter Money, Festive Fortune and Hampers & Roses.

We also launched a number of themed games such as Pac-Man, Treasure Ireland and Scrabble. In all, we had 38 different Scratch Card games on offer at various stages during the year, ranging in price from €1 to €10.

Players won €99.7 million in prizes including cash, cars and holidays.

On Saturday 13 March, 2010, using over 1.5 tonnes of fireworks, the National Lottery's **Skyfest** spectacular lit up the skies over the magnificent King John's Castle in Limerick. This event was broadcast live to the nation on RTÉ ONE television, thanks to the National Lottery in partnership with the St. Patrick's Festival.

Over 50,000 people turned out to view the breathtaking show which was choreographed to a vibrant soundtrack. This was the third time the National Lottery took the Skyfest fireworks and musical event on tour.

Mar bhíogcheannach, chuir an titim ginearálta i líon na gcustaiméirí in asraonta miondíola isteach ar dhíolachán Scríobchártaí i 2010. Rinne an drochaimsir i dtús na bliana agus arís mí na Nollag, anuas ar athruithe ar nósanna siopadóireachta thomholtóirí, an scéal níos measa fós.

## TV Gameshows

2010 represented a major milestone for our longest running Scratch Card game and TV Gameshow, Winning Streak, which celebrated its 20th anniversary. This gives Winning Streak a unique place in the history books as the longest running and richest European TV Gameshow ever.

Since first airing in 1990, Winning Streak has given away over €120 million in prizes with hundreds of thousands of people tuning in every Saturday evening from September to May.

To mark the anniversary, RTÉ screened a special one hour documentary looking back over the 20 years of Winning Streak's unique appeal.

During the year, 240 players on the Winning Streak TV Gameshow shared prizes to the value of €9.9 million, including 77 holidays and 43 cars. Chris O'Sullivan from Passage West, Cork was the biggest winner, collecting a prize of €318,000 on the show in April.

Our other popular TV Gameshow, Big Money Game, returned for the summer months and culminated with a fantastic trip to New York for 39 winners and their guests.

Over the 13 weeks of the show, €3 million was paid out in Big Money Game prizes, with 60 holidays and 22 cars won along with great cash prizes. The biggest winner on the TV Gameshow was Helen Walsh from Mayfield, Cork who won €310,000 in June.

The Deal or No Deal Scratch Card TV Gameshow continued its run on TV3 for the early part of the year, with hundreds of thousands of people tuning in to watch players pit their wits against the infamous banker. Mary Egan from Dublin 9 won the highest prize of the season, €250,000, in January.

### TellyBingo

TellyBingo continued to expand its appeal during 2010 with a 7.2% increase in sales to €15.3 million. This growth was mainly driven by the introduction of a third TellyBingo weekly draw in September. There are now three TellyBingo shows on RTÉ TV each week on Tuesdays, Thursdays and Fridays.

Players of TellyBingo enjoyed a 71.6% prize payout level winning a total of €11.0 million in 2010. Overall, there were 414 full house winners and 44 Snowball winners in 2010, the largest of which was €110,000 shared by nine winners on 21 May.

There were a number of special promotions on TellyBingo throughout the year, including the addition of €50,000 to the snowball prize in October. This led to the largest individual snowball win of €65,000 on 26 November which was won by a player from Passage West, Cork.

In addition, to celebrate the introduction of the Thursday draw, a special prize of a car worth €25,000 was added for the first outright Snowball winner. The car was won by Kathleen Hageman from Laytown, Co. Meath together with her €50,000 Snowball prize.

Supported by the National Lottery through the Department of Health, **Order of Malta Ireland** has long been involved in community care, the transport of elderly people and home nursing as well as first aid provision ambulance service and training. Members receive full training in first aid and nursing skills up to EMT level.

Order of Malta Ireland is free to join, and its volunteers learn new skills and how to work as part of a team. It is a voluntary organisation and members can give as little or as much of their time as they can.

There is also a very active Cadet organisation which the Order uses to introduce people aged from 10 to 16 years to the practice of first aid, nursing and personal development.

### TellyBingo

Lean TellyBingo de bheith ag cur lena mhealladh le linn 2010 agus bhí méadú 7.2% ar a dhíolachán go dtí €15.3 milliún. Tabhairt isteach an tríú crannchur seachtainiúil TellyBingo mí Mheán Fómhair an phríomhchúis leis an bhforbairt seo. Bíonn trí sheó TellyBingo ar theilifís RTÉ gach seachtain anois – Dé Máirt, Déardaoin agus Dé hAoine.

Bhí leibhéal íocaíochta amach duaise de 71.6% ag imreoirí TellyBingo i 2010 agus bhuaigh siad iomlán de €11.0 milliún. Ina iomláine, bhí 414 buaiteoir tí láin agus 44 buaiteoir Snowball i 2010. Bhí €110,000 ar an gceann ba mhó agus roinneadh an duais ar naoi mbuaiteoir ar 21 Bealtaine.

Bhí roinnt promóisean speisialta TellyBingo ar leith ann le linn na bliana ina measc €50,000 breise a bheith curtha leis an duais Snowball mí Dheireadh Fómhair. Bhí an bua Snowball ba mhó ann ar 26 Samhain nuair a bhain imreoir ón bPasáiste, Corcaigh, €65,000.

De bhreis air seo, chun seoladh chrannchur an Déardaoin a cheiliúradh, cuireadh duais speisialta de ghluaisteán dar luach €25,000 ar fáil don chéad ghlan-bhuaiteoir Snowball. Bhuaigh Kathleen Hageman as An Inse, Co. na Mí, an gluaisteán anuas ar a duais Snowball de €50,000.



## Monday Million

Total sales of Monday Million games were €20.6 million, with €3.7 million of this amount accounted for by the new Monday Million Plus game launched on 10 May.

For an extra 50 cent, players now have a chance of winning €500,000 in an extra draw which takes place live on TV3 in conjunction with the main Monday Million draw.

Winners of the Monday Million draw shared €9.2 million in prizes during 2010. Already €2.2 million has been paid out to Monday Million Plus winners, with the first of three top prizes won in August.

For the October Bank Holiday weekend, in addition to the usual prize of €10,000, a Mitsubishi ASX car worth €25,000 was on offer for players who matched 5 numbers and the Bonus number in Monday Million and Monday Million Plus draws. We had one winner with the ticket sold in Superquinn, James Street, Kilkenny.

## Millionaire Raffle/Sweepstakes

Our first Millionaire Raffle game was introduced in 2008 and we extended the game to four draws in 2009.

In the course of 2010, we continued with two Millionaire Raffle draws – one at Easter and one at Christmas – and also introduced players to an exciting variation on the limited edition theme with National Lottery Sweepstakes.

This game had an innovative feature in that the top 25 winners were paired with 25 horses in the National Lottery Sweepstakes Race at the Curragh Racecourse on Derby Day, 27 June.

These winners and their guests enjoyed a VIP weekend at the K Club which culminated in an exciting afternoon at the Curragh when the overall €1 million winner was determined by the outcome of the race. Trevor Cawley from Sligo was the lucky millionaire winner, while all the other finalists won cash prizes ranging from €10,000 to €500,000.

In addition to the National Lottery Sweepstakes winner, there were a total of four other millionaires created by Millionaire Raffle. At Easter a €1 million winning ticket was bought in Swords, Co. Dublin and another in Navan, Co Meath, while at Christmas €1 million wins went to Cork and Waterford where the eight member syndicate from Brady's Quality Foods shared the prize.

Millionaire Raffle and the associated National Lottery Sweepstakes game generated sales of €10.6 million in 2010.

### All or Nothing

2010 was the first full year of the daily All or Nothing game. Launched in October 2009, this game became established in the National Lottery portfolio during the year. Sales were €9.9 million, up from €3.4 million in 2009. This draw takes place in the National Lottery Head Office each evening under the supervision of KPMG.

In 2010, the National Lottery sponsored a special **Celebrity Winning Streak TV Gameshow** which was broadcast on New Year's Eve 2010 on RTÉ ONE television.

It was a glittering night of stars and those who participated on behalf of their chosen charities were Westlife's Nicky Byrne; Gold Medal Boxer Katie Taylor, Musician Sharon Shannon, Actor Jim Bartley and Celebrity Chef Neven Maguire. Between them, they won €199,200 for their chosen charities.

The charities who benefitted from this special National Lottery TV Gameshow were Barnardos; Our Lady's Children's Hospital, Crumlin; Clare Crusaders; DSPCA; Irish Heart Foundation; Irish Premature Babies; Barretstown; Bóthar; Simon Community and Lauralynn Hospice.

### All or Nothing

Baineadh amach díolachán de €9.9 milliún, méadú ó €3.4 milliún i 2009. Tarlaíonn an crannchur seo in Ardoifig an Chramchuir Náisiúnta gach tráthnóna faoi stiúir KPMG.



In total, €6.1 million was paid out in prizes, with six top prize winners winning €500,000 each. Five of these won as a result of having all 12 winning numbers correct, including Grace Sherry from Ballymote, Co. Sligo who purchased her ticket in Supervalu, Ballymote. A Cork couple who matched no numbers on their All or Nothing ticket purchased in Mace Store in Pouladuff Road, Cork also won €500,000. The husband regularly matches 10 numbers and couldn't believe he'd won top prize for matching none!

### National Lottery Play Online

National Lottery Play Online participation continues to grow and we now have 15,000 players playing our draw games and instant win games online. This represents a 150% increase from the 6,000 players who registered to play online in 2009.

Revenue from this channel of business has also increased significantly, up to €3.7 million from €744,000 in 2009, as players enjoy the convenience of playing Lotto, EuroMillions and instant win games over the internet.

As internet usage increasingly becomes part of players' daily lives, we expect that this business channel will continue to be an important growth area for the National Lottery.

In 2010, we had our first online Lotto jackpot win when €5,513,556 was won by a Cork based online family syndicate in February. One of the family members hoped to realise a long-held ambition by travelling to Australia and scuba diving in the Barrier Reef.

Throughout 2010, there was a continued focus on technical and digital communications development. We enhanced our website and introduced a new iPhone application with a number of features including results checking and random number generation options.

## Operations

The level of activity required to support the growing National Lottery game portfolio continues to rise. In 2010, the total number of individual transactions handled was 267 million. During the year, we managed 854 individual draws and now have 22 regular game draws per week.

Total operating expenses for the year were €108.4 million, down 4.3% from €113.3 million in the previous year. This includes €48.1 million agents' commission representing 6.2% of total sales. In line with the reduction in sales volumes, commission paid to agents was down by 5.6% from €50.9 million in 2009.

Other costs of sales also reduced, down to €38.1 million from €39.6 million in the previous year. Administration costs for the year were reduced to €19.4 million from €19.7 million and equate to 2.5% of sales.

Our retail side of the business continues to grow and at the end of 2010, we had 3,813 agents, up from 3,794 in the previous year.

We continued to improve our player support services in store with the installation of 930 self service ticket checkers, bringing the total number in stores to 3,400. We also upgraded 950 stores to improve broadband capability and continued the roll-out of digital display screens in the top retail outlets.

**Coláiste Mhuire Community Sports** is a unique schools/community partnership where the school board, along with the local community, worked together to provide all weather playing facilities for the students. National Lottery assistance also helped with the provision of dressing room facilities and floodlighting.

Tennis, soccer and Irish language camps are run during the summer. Coláiste Mhuire Community Sports has two all weather pitches and a sports hall. Funding has been raised by the local community's fundraising efforts, along with the Parents Council. These sports facilities are also used by the various club and sporting organisations in Johnstown and the surrounding areas.

Báineann cumainn agus eagraíochtaí spóirt i mBaile Sheáin agus an ceantar máguaírd úsáid as na haiseanna spóirt seo chomh maith.

Le linn 2010 bhí fócas leanúnach ar fhorbairt na cumarsáide teicniúla agus digití. D'fheabhsaíomar ár suíomh gréasán agus thugamar isteach feidhmchlár iFón le raon gnéithe ar a n áirítear seiceáil torthaí agus roghanna chun uimhreacha randamaí a ghiniúint.

## Oibríochtaí

Bíonn an leibhéal gníomhaíochta a bhíonn riachtanach chun freastal ar phunann cluichí an Chrannchuir Náisiúnta, atá ag fás, ag meadú i gcónaí. I 2010 láimhseáladh 267 milliún idirbheart aonair. Le linn na bliana, bhí 854 crannchur ar leith ann agus bíonn 22 cluiche crannchuir in aghaidh na seachtaine anois againn.

Bhí €108.4 milliún ar chostais oibríochta iomlána na bliana, laghdú 4.3% ó €113.3 milliún an bhliain roimhe sin. Áirítear anseo €48.1 milliún ar choimisiún ghníomhairí, arbh ionann é agus 6.2% den díolachán iomlán. Ag teacht leis an laghdú ar mhéid an díolacháin, bhí laghdú 5.6% ar an gcoimisiún a íocadh le gníomhairí ó €50.9 milliún i 2009.

Laghdaíodh chomh maith costais eile díolacháin go €38.1 milliún ó €39.6 milliún an bhliain roimhe sin. Laghdaíodh na costais riarracháin don bhliain go dtí €19.4 milliún ó €19.7 milliún agus is ionann iad agus 2.5% den díolachán.

Leanann taobh miondíola d'ár ngnó de bheith ag fás agus faoi dheireadh 2010, bhí 3,813 gníomhaire againn, meadú ó 3,794 an bhliain roimhe sin.

Leanamar de bheith ag feabhsú ár seirbhísí tacaíochta d'imreoirí sna siopaí trí 930 meaisín féinseirbhís seiceála ticéad a chur ar fáil, rud a fhágann go bhfuil 3,400 díobh ar fáil anois sna siopaí. D'usaghrádaíomar 950 siopa chun a n acmhainní leathanbhanda a fheabhsú agus leanamar de rolladh amach scáileán digiteacha taispeána sna hasraonta miondíola is mó.



During the year, our employee numbers increased by 4 to 103 people as we employed additional resources to develop our internet capability and handle the increased number of games and draws on the market.

I'd like to thank everyone working in the National Lottery for their hard work and commitment during the year, together with our agents who continue to provide much valued support at retail level.

The National Lottery is committed to operating to the highest possible standards and to maintaining accreditation to a number of internationally recognised business standards.

The operation of a Quality Management System and an Information Security Management System resulted in the Company maintaining accreditation to ISO 9001 and ISO 27001 respectively during the year under review. We have also achieved accreditation to the World Lottery Association's Security Control Standard which specifies security control requirements specific to Lottery operations.

Last year, the National Lottery achieved certification to the ISO 14001 Environmental Management System Standard, which provides us with a risk management tool to control, manage and improve its impact on the environment.

### Responsible Gaming

The National Lottery is committed to best practice in relation to responsible gaming. A key issue for us in raising as much money as we can for good causes is to ensure that the National Lottery does not encourage excessive play and that National Lottery tickets are not sold to persons under 18 years of age.

While it is generally accepted internationally that lottery draw-based games carry lower risks than other forms of gaming, we are constantly vigilant in ensuring that we continue to operate in a socially responsible way. We have a corporate social responsibility programme in place, with the protection of minors and the potentially vulnerable at the very heart of its ethos.

Our website also offers practical guidance for players who are concerned that gaming may be playing too large a part in their lives.

### Sponsorship

We were pleased to sponsor National Lottery Skyfest again in 2010 as part of the St. Patrick's Festival celebrations. This spectacular fireworks event was broadcast live on RTÉ One Television from Limerick against the dramatic backdrop of King John's Castle. Crowds of over 50,000 people attended the spectacle on Saturday 13 March and also participated in a live Lotto draw with €2 million added.

In addition, over 250,000 TV viewers were able to enjoy the National Lottery Skyfest broadcast which featured footage from several good causes that have received National Lottery funding, including the new Thomond Park Stadium.

**39 Big Money TV Gameshow winners**  
and their guests travelled to New York in October 2010 with the National Lottery for the trip of a lifetime. RTÉ TV Gameshow host Brian Ormond and his fiancée Pippa O'Connor accompanied the winners on their adventures.

During their six-day luxury break, the winners went to see smash-hit Broadway show 'Billy Elliott'; took helicopter rides across the Hudson River; enjoyed evening dinner on the 'Star of America' luxury yacht, against the nighttime backdrop of an uplift Statue of Liberty and the Manhattan skyline.

All winners also won €2,500 as part of their prize and were able to treat themselves to some retail therapy on 5th Avenue.

D'fhreastal slua de bhrefis is 50,000 ar an taispeántas Dé Sathairn, 13 Mártá, agus ghlac siad páirt chomh maith i gcrannchur beo Lotto a raibh €2 milliún curtha leis.

Thairis sin, bhí lucht féachana de brefis ar 250,000 in ann taitneamh a bhaint as craoladh Skyfest an Chrannchuir Náisiúnta a raibh píosaí scannán air a léirigh go leor dea-chúiseanna, a bhfuil maoiniú faigthe acu ón gCrannchur Náisiúnta, ina measc Staidiam nua Pháirc Thuamhan.



## Good Causes

In 2010, we raised €243.7 million or 31.6 % of sales in funds for good causes. Interestingly, our research shows that whilst players are aware that an amount from every euro played goes to fund work in communities countrywide, they consistently underestimate the level of funds raised. In fact the cumulative figure since the National Lottery commenced operations in 1987 currently stands at the very substantial amount of over €3.6 billion.

Throughout the year we continued our 'Dream Winner' segment on the Winning Streak TV Gameshow. This features a televised broadcast from National Lottery Beneficiary projects from around Ireland each week allowing viewers to see the benefits made possible by their playing of National Lottery games.

Last year, National Lottery players contributed to the millions of euro invested in projects and communities within the four categories of Youth, Sport, Recreation and Amenities; Health & Welfare; Arts, Culture & National Heritage and the Irish Language.

One such project was Macra Na Feirme, a vibrant organisation for young people comprising over 300 clubs and 9,000 members, which exists to promote rural development and the personal development of its members. In 2010, Macra na Feirme received €561,226 from the National Lottery funded Youth Services Grant Scheme administered by the Office of the Minister for Children and Youth Affairs.

In the sports area, many of our leading athletes, including hurdler Derval O'Rourke, boxer Katie Taylor, and swimmer Gráinne Murphy, were recipients of grants from the Irish Sports Council part funded by the National Lottery.

The Arts Council continues to receive National Lottery funds which are distributed to community projects such as the Waterford Healing Arts Trust, located in Waterford Regional Hospital and the Stokestown International Poetry Festival.

The Oriel Cultural Centre, Dundalk was one of six regional Comhaltas Ceoltóirí Éireann resource centres to receive National Lottery funding. This Irish language hub provides facilities for teaching, rehearsal, performance and sessions, along with recording and archiving facilities.

We are conscious that behind these initiatives and the many other projects which benefit from National Lottery funding, there are thousands of volunteers dedicated to achieving the best for their communities and would like to thank them for their commitment.

**National Lottery Play Online**

participation continues to grow and there are now 15,000 players playing our draw games and instant win games online.

Play Online revenues have increased significantly, up to €3.7 million from €744,000 in 2009. Lotto, EuroMillions and Instant Win games can now be played on the internet.

The first ever online Lotto jackpot win in Ireland was recorded in February when a Cork based family syndicate won €5,513,556.

## Report of the Directors

The Directors have pleasure in submitting their twenty fourth annual report, together with the audited financial statements of the Company, for the year ended 31 December, 2010, in fulfilment of their obligations under the Companies Acts, 1963 to 2009.

### 1. The Company

The Company carries on the business of operating the National Lottery under Licence from the Minister for Finance in accordance with the provisions of the National Lottery Act, 1986.

80% of the issued share capital is held by An Post and 20% is held by the Minister for Finance.

### 2. Results for the Year

The results for the year are set out on page 50.

### 3. Business Review

The information required by Section 13 of the Companies (Amendment) Act, 1986, on the development of the business and important events, is included in the Chairman's Statement and Review of Operations on pages 10 to 31.

As described therein, the Company had a substantial surplus of €244m in 2010 (2009: €264m) to the benefit of the Beneficiary Fund. This resulted from sales of €772m in 2010 (2009: €815m).

In monitoring the Company's performance, the Directors and management have regard to a range of key performance indicators (KPIs).

The above KPIs are within the terms of the Licence to operate the National Lottery.

The key risks and uncertainties facing the future development of the Company include the retention of the Company's licence to operate the National Lottery, the Company's significant reliance upon its IT infrastructure and retailer operations, the impact of general economic factors on the Company and the introduction of new games and channels. The Directors have developed a range of strategies to address these and other risks faced by the Company. The Corporate Governance Statement on page 37 sets out the Company's policies and approach to risks and the related internal control procedures and responsibilities.

### 4. Directors, Secretary and their interests

The Directors of the Company are appointed by the Minister for Finance for a fixed term, usually three years, and their conditions of appointment and fees are set out in writing.

The terms of office of Niamh McGowan and Oliver Wilkinson expired on 5 November, 2010. Caroline Murphy was appointed and Oliver Wilkinson was re-appointed from that date.

The Directors and Secretary who held office at 31 December, 2010 had no interest in the shares in, or debentures of, the Company or any Group Company.

Tá an t-eolas a éiltear faoi réir Alt 13 d'Acht na gCuideachtaí (Leasú) 1986, ar phorbairt an ghnó agus ar imeachtaí tábhachtacha, clúdaithe i Ráiteas an Chathaoirligh agus san Athbhreithniú Oibrfocantaí ar leathanaigh 10 go 31.

Mar atá ráite ansin, bhí barrachas substaintiúil de €244m. ag an gComhlacht i 2010 (2009: €264m.) agus cuireadh é chun leasa Chiste na dTaibhithe. D'eascair an toradh seo as díolachán de €772m i 2010 (2009: €815m.).

Ar na heochair-rioscaí agus na neamhchinnteachtaí a gcaithfear aghaidh a thabhairt orthu, má táthar leis an gComhlacht a phorbairt, tá coinneáil cheadúnas an Chomhlachta chun an Crannchur Náisiúnta a rith, chomh mór is atá an Comhlacht i dtuilleamaí a infreastruchtúr TF agus a oibríochtaí miondíola, éifeacht tosca eacnamaíochta ginearálta ar an gComhlacht agus cluichí is cainéil nua do theacht isteach. ## Report of the Directors

### 5. Employees

The Company and An Post, which provides seconded staff to the Company, are equal opportunities employers. All applications for employment are given full and fair consideration, due regard being given to the aptitude and ability of the individual and the requirements of the position concerned.

All persons are treated on equal terms as regards training, career development and promotion.

The well-being of staff working in the Company is safeguarded through the strict adherence to health and safety standards. The Safety, Health and Welfare at Work Act, 2005 imposes certain requirements in respect of staff and the Company has taken the necessary action to ensure compliance with the Act, including the adoption of a Safety Statement.

### 6. Corporate Governance

Maintaining high standards of corporate governance continues to be a priority of the Directors of An Post National Lottery Company. The Board has developed its corporate governance policy so as to give effect to the Code of Practice for the Governance of State Bodies issued by the Department of Finance and to apply as appropriate the relevant main and supporting principles of good governance in the Combined Code issued by the Financial Reporting Council in the UK. While the provisions of the Combined Code are of direct relevance only to listed companies, the Board feels that their application, where appropriate, assists the Company in its compliance with best corporate governance practice.

The Directors are accountable to the shareholders for good corporate governance and this report addresses how the relevant main and supporting principles of the Code of Best Practice for the Governance of State Bodies and the Combined Code have been applied within An Post National Lottery Company.

#### The Board

The Company is controlled through its Board of Directors. The Board's main roles are to oversee the operation of the Company, to provide leadership to the Company, to approve the Company's strategic objectives and to ensure that the necessary financial and other resources are made available to enable them to meet those objectives. The Board, which meets monthly during the year, has a schedule of matters reserved for its approval.

The specific responsibilities reserved to the Board include: setting Company strategy and approving an annual budget and medium-term projections; reviewing operational and financial performance; approving major capital expenditure; ensuring compliance with the terms of the licence to operate the National Lottery; reviewing the Company's systems of financial control and risk management; ensuring that appropriate management development and succession plans are in place; reviewing the environmental, health and safety performance of the Company; approving the appointment of the Company Secretary; and ensuring that a satisfactory dialogue takes place with shareholders.

The Board has delegated the following responsibilities to management: the development and recommendation of strategic plans for consideration by the Board that reflect the longer-term objectives and priorities established by the Board; implementation of the strategies and policies of the Company as determined by the Board; monitoring of the operating and financial results against plans and budgets; development of controls over the operation of draws, prioritising the allocation of technical and human resources; and developing and implementing risk management systems.

Déantar cúram de dhea-bhail na foirne, atá ag obair leis an gComhlacht trí chloí go doch le caighdeán shábháilteachta agus sláinte. Leagann An tAcht um Shábháilteachta, Sláinte agus Leas ag an Obair, 2005, dualgais áirithe i leith na foirne agus tá na céimeanna riachtanacha glactha ag an gComhlacht chun déanamh de réir an Acharta. Áirítear orthusan glacadh le Ráiteas Sábháilteachta.

### 6. Rialachas Corparáide

Tosaíocht é ag Stiúrthóirí Chomhlacht Chranncuir Náisiúnta an Phoist ardchaighdeán rialachais chorparáide a choinneáil. D'fhobair an Bord a pholasáf ar rialachas corparáide le go mbeadh feidhm ag an gCód Cleachtais um Rialachas Chomhlachtaí Stáit a d'eisigh an Roinn Airgeadais agus chun feidhm a thabhairt nuair is cuí do phríomhphrionsabail agus do phrionsabail thacaíochta ábhartha um dhea-rialachas atá sa Chomhchód a d'eisigh an Financial Reporting Council sa Ríocht Aontaithe. Siúd is go mbaineann forálacha an Chomhchód go díreach le cuideachtaí liostáilte amháin, braitheann an Bord go gcuindíonn a bhfeidhmiú mar is cuí leis an gComhlacht chun sár chleachtas rialachais corparáide a chomhlíonadh

Tá na Stiúrthóirí freagrach do na scairshealbhóirí as dearialachas corparáide agus pléann an tuarascáil seo leis an tsúl inar cuireadh i bhfeidhm na príomhphrionsabail agus na prionsabail thacaíochta ábhartha atá le fáil sa Chóid Sár-chleachtais um Rialachas Chomhlachtaí Stáit agus sa Chomhchód i gcás Chomhlacht Chranncuir Náisiúnta an Phoist.

#### An Bord

Rialaítear an Comhlacht trína Bhord Stiúrtha. Is iad príomhróil an Bhoird maoirseacht a dhéanamh ar obríochtaí an Chomhlachta, cinnireacht a sholáthar don Chomhlacht, cuspóirí straitéisearcha an Chomhlachta a fhaomhadh agus deimhin a dhéanamh de go gcuirtear ar fáil na hacmhainní riachtanacha airgeadais agus eile chun gur féidir leo na cuspóirí sin a bhaint amach. Uair sa mhí a thagann an Bord le chéile le linn na bliana. Tá sceideal ábhar atá forchoimeádta le faomhadh ag an mBord.

I measc na sainfhreagrachtaí atá forchoimeádta don Bhord tá: straitéis an Chomhlachta a cheapadh agus an buiséad bliantúil agus na réamh-mheastacháin mheántéarmacha a fhaomhadh; feidhmiú obríoch agus airgeadais a athbhreithniú; mórchaiteachas caipítil a fhaomhadh; deimhin a dhéanamh de go bhfuil téarmaí an cheadúnais chun an Crannchur Náisiúnta a reáchtáil á gcomhlíonadh; córais an Chomhlachta um rialú airgeadais agus bainistiú riosca a athbhreithniú; deimhin a dhéanamh de go bhfuil pleannanna cuí i bhfeidhm chun forbairt agus comharbaíochta na bainistíochta a chinntí; feidhmiú an Chomhlachta ó thaobh na timpeallachta agus círsai sláinte is sábháilteachta de a athbhreithniú; ceapadh Rúnaí an Chomhlachta a fhaomhadh; deimhin a dhéanamh de go mbíonn idirphlé sásúil ann leis na scairshealbhóirí.

## Report of the Directors

### The roles of the Chairman and Chief Executive

The Chairman leads the Board in the determination of its strategy and in the achievement of its objectives. The Chairman is responsible for organising the business of the Board, ensuring its effectiveness and setting its agenda. The Chairman facilitates the effective contribution of non-executive Directors and constructive relations between the executive Director and non-executive Directors, ensures that Directors receive accurate, timely and clear information and manages effective communication with shareholders.

The Chief Executive has direct charge of the Company on a day to day basis and is accountable to the Board for the financial and operational performance of the Company.

### Senior Independent Director

The Board has considered the matter of designating a recognised senior member other than the Chairman to whom concerns can be conveyed and, in view of the manner of appointment of Directors, the shareholding structure and existing Board procedures, has concluded it is not necessary in the circumstances.

### Directors and Directors' independence

The Board currently comprises the Chairman, five non-executive Directors and the Chief Executive. The names of the Directors together with their biographical details are set out on pages 32 and 33. The positions of Chairman and Chief Executive are held by different persons. Given its status as a State Company, its shareholding structure and the appointment of the Directors by the Minister, the Board believes that the criteria normally used by the board of a listed Company in considering the independence of its Directors do not apply to the Company. The Board includes independent non-executive Directors who constructively challenge and help develop proposals on strategy and bring strong independent judgement, knowledge, and experience to the Board's deliberations. The independent Directors are of sufficient calibre and number that their views carry significant weight in the Board's decision making.

The Combined Code requires the Chairman to hold meetings with the non-executive Directors without the executive Director being present. The Board has formal procedures in place in this regard.

Directors have the right to ensure that any concerns they have, which cannot be resolved, about the running of the Company or a proposed action, are recorded in the Board minutes. In addition, upon resignation, a non-executive Director will be asked to provide a written statement to the Chairman, for circulation to the Board, if they have any such concerns.

The Directors are given access to independent professional advice at the Company's expense, when the Directors deem it is necessary in order for them to carry out their responsibilities.

Éascaíonn an Cathaoirleach ranmháirtíoch éifeachtach na Stiúrthóirí neamh-fheidhmiúchán agus deachaidreamh idir iad agus an Stiúrthóir feidhmiúchán agus cintíonn sé go bhfaigheann na Stiúrthóirí eolas crínn, tráthúil agus soiléir. Bainistíonn sé freisin cumarsáid éifeachtach leis na scairshealbhóirí.

Is ag an bPríomhfeidhmeannach atá údarás díreach ar an gComhlacht ó lá go chéile agus tá sé freagrach don Bhoird as feidhmiú oibríoch agus airgeadais an Chomhlachta.

### Stiúrthóir Sinsearach Neamhspleách

Scrúdaigh an Bord an fhéidearthacht go gceapfaí comhalta sinsearach inaitheanta, seachas an Cathaoirleach, mar dhuine go bhféadfáí ábhair inní a chur faoina bhráid agus i ngeall ar an tstí a gceaptar Stiúrthóirí, struchtúr an scairchaipítíl agus gnáthaimh reatha an Bhoird, shocraigh an Bord nach mbeadh a leithéid de shocruí riachtanach faoi na cúinsí sin.

### Stiúrthóirí agus Neamhspleáchas na Stiúrthóirí

San am i láthair, is iad comhaltaí an Bhoird an Cathaoirleach, cùigear Stiúrthóir neamh fheidhmiúchán agus an Príomhfeidhmeannach. Tá ainmneacha na Stiúrthóirí mar aon lena sonraí beathaísnéise leagtha amach ar leathanach 32 agus 33. Daoine difriúla atá i bpost an Cathaoirleagh agus i bpost an Phríomhfeidhmeannáigh. Nuair a chuirtear san áireamh gur Comhlacht Stáit atá i gceist, struchtúr an scairchaipítíl agus gurb é an tAire a cheapann na Stiúrthóirí, measann an Bord nach dtagann na gnáth-chritéir, a d'úsáidfeadh stiúrthóirí chuideachta liostáilte chun neamhspleáchas a Stiúrthóirí a mheas, i bhfeidhm sa chás seo. Airítear ar an mBord Stiúrthóirí neamh-fheidhmiúchán neamhspleácha a cheistíonn ar bhealach dearfach moltaí faoi chúrsaí straitéis agus a chabhraíonn le hiad a fhobairt agus tuggann siad breithiúnas láidir, neamhspleách, maille le heolas agus taithí agus ceisteanna á scrúdú ag an mBord. Tá na Stiúrthóirí neamhspleácha líonmhar a dhóthain agus de chaigndeán sách ard le go mbeadh tionchar nach beag ag a dtuairimí ar chinntí an Bhoird.

Faoin gComhchód tá dualgas ar an gCathaoirleach cruinnithe a bheith aige leis na Stiúrthóirí neamh-fheidhmiúchán gan an Stiúrthóir feidhmiúchán a bheith i láthair. Tá gnáthaimh fhormíúla chuige seo i bhfeidhm ag an mBord.

Tá sé de cheart ag Stiúrthóirí deimhin a dhéanamh de go gláraitear i miontuairiscí an Bhoird aon ábhar inní gan réiteach atá acu faoi réachtáil an Chomhlachta nó faoi bheart atá molta. De bheis air sin, iarrfar ar aon Stiúrthóir neamh-fheidhmiúchán a éiríonn as oifig, ráiteas i scribhinn a thabhairt don Cathaoirleach, le cur thart ar an mBord, má tá aon ábhar inní aige.

Cuirtear comhairle neamhspleách phroifisiúnta ar fáil do na Stiúrthóirí ar chostas an Chomhlachta má shíleann na Stiúrthóirí go bhfuil gá lena leithéid le go bhfeadfaidís a gcuide dualgas a chomhlíonadh.

## Report of the Directors

All of the non-executive Directors are independent of management. The Board includes both the Chief Executive of the Company's parent company, An Post, as Chairman and James Hyland, a non-executive director of An Post. The Board considers all other non-executive Directors to be independent on the basis of the following:

- they have not been an employee of the Company within the last five years;
- they have no material business relationship with the Company, nor have they had any within the last three years;
- they receive no remuneration other than through Director's fees;
- they have no close family ties with any of the Company's advisers, Directors or senior employees; and
- they hold no cross-directorships and have no significant links with other Directors through involvement in other companies or bodies.

### Professional development

On appointment, all new Directors take part in an induction programme when they receive information about the Company, the role of the Board and the matters reserved for its decision, the terms of reference and membership of the Board and its principal committees, the Company's corporate governance practices and procedures, including the responsibilities delegated to Company senior management and the latest financial information about the Company. This will typically be supplemented by meetings with key senior executives. Throughout their period in office, the Directors are continually updated on the Company's business, the competitive and regulatory environments in which it operates, corporate social responsibility matters and other changes affecting the Company and the lottery industry as a whole, by written briefings and meetings with senior executives. Directors are also advised on appointment of their legal and other duties and obligations as a Director, both in writing and in face-to-face meetings with the Company Secretary. They are also updated on changes to the legal and governance requirements of the Company and upon themselves as Directors.

### Performance evaluation

All Directors are appointed to the Board by the Minister for Finance in accordance with Section 14 of the National Lottery Act, 1986 and their terms of office (generally three years) are set out in writing.

The Board has adopted and performed a formal process for the annual evaluation of the performance of the Board and its principal Committees. The Board considers that the introduction of any further formal evaluation of individual Directors is not necessary given the manner of appointment of Directors, the shareholding structure and existing Board procedures.

### The Company Secretary

The Company Secretary is a full time employee of the Company's parent company, An Post. The Company Secretary is responsible for advising the Board, through the Chairman, on all governance matters. All Directors have access to the advice and services of the Company Secretary. The Company's Articles of Association provide that the appointment and removal of the Company Secretary is a matter for the full Board.

Tá glactha ag an mBord le príoseas foirmiúil chun meastóireacht bhliantúil a dhéanamh ar fheidhmiú an Bhoird agus a phríomhchoistí. Tá an Bord den tuairim nach mbeadh aon mheastóireacht foirmiúil bhreise ar Stiúrthóirí aonair riachtanach nuair a chuirtear san áireamh an tsúl ina gceaptar Stiúrthóirí, an struchtúr scairsheilbhe agus na gnáthaimh atá ag an mBord faoi láthair.

### Rúnaí an Chomhlachta

Fostaí lánaimseartha de chuid na máthair-chuideacha, An Post, é Rúnaí an Chomhlachta. Tá Rúnaí an Chomhlachta freagrach as eolas a choinneáil leis an mBord tríd an gCathaoirleach ar gach gnó rialachais. Tá fáil ag na Stiúrthóirí uile ar chomhairle is ar sheirbhísí Rúnaí an Chomhlachta. Faoi réir na nAirteagal Comhlachais is gnó don Bhord ina iomláine é Rúnaí an Chomhlachta a cheapadh is a bhriseadh.

### Information

Regular reports and papers are circulated to the Directors in a timely manner in preparation for Board and Committee meetings. These papers are supplemented by information specifically requested by the Directors from time to time.

The non-executive Directors receive monthly management accounts and regular management reports and information which enables them to scrutinise the Company's and management's performance against agreed objectives.

### Relations with shareholders

The Board and management maintain an ongoing dialogue with the Company's shareholders on strategic issues. In addition, under the National Lottery Act, 1986, certain operational matters require the approval of the Minister for Finance in respect of which ongoing contact with the Minister is maintained.

The Chairman gives feedback to the Board on issues raised with him by the shareholders. All Directors normally attend the Annual General Meeting and shareholders are invited to ask questions during the meeting and to meet with Directors after the formal proceedings have ended.

### Internal Control

An ongoing process exists for identifying, evaluating and managing the significant risks faced by the Company. This process, which is based on the Combined Code Guidance for directors issued by the Institute of Chartered Accountants in England and Wales (the Turnbull Guidance), is periodically reviewed by the Directors and has been in place throughout the accounting period and up to the date the financial statements were approved.

In accordance with the guidance of the Turnbull committee, the Directors are responsible for the Company's system of internal control, should set appropriate policies on internal control, should seek regular assurance that will enable them to satisfy themselves that the system is functioning effectively and should ensure that the system of internal control is effective in managing risks in the manner which it has approved. Such a system is designed to manage rather than eliminate business risks and can provide only reasonable rather than absolute assurance against material misstatement or loss.

The Directors have continued to review the effectiveness of the Company's system of financial and non-financial controls, including operational and compliance controls, risk management and the Company's high level internal control arrangements. These reviews have included an assessment of internal controls by management, management assurance of the maintenance of controls, reports from the internal auditor and reports from the external auditor on matters identified in the course of its statutory audit work.

The Company views the careful management of risk as a key management activity. Managing business risk to deliver opportunities is a key element of all activities. This is done using a simple and flexible framework which provides a consistent and sustained way of implementing the Company's values. These business risks, which may be strategic, operational, reputational, financial or environmental, should be understood and visible. The business context determines in each situation, the level of acceptable risk and controls.

## Tuarascáil na Stiúrthóirí

### Eolas

Cuirtear tuarascála agus páipéis thart ar na Stiúrthóirí in am tráth do chruinnithe Boird is Coistí. Cuirtear leis na páipéis seo trí eolas ar leith a sholáthar de réir mar a iarrann Stiúrthóirí é ó am go chéile.

Faigheann na Stiúrthóirí neamhfheidhmiúcháin cuntas mhíosúla bainistíocha maille le tuairiscí agus eolas rialta ón mbainistíocht, rud a chuireann ar a gumas mionscrúdú a dhéanamh ar fheidhmiú na bainistíocha agus an Chomhlachta i gcomparáid le spriocanna aontaithe.

### Caidreamh le Scairshealbhóirí

Bíonn idirphlé leanúnach idir an Bord is an bhainistíocht le scairshealbhóirí an Chomhlachta faoi nithe straitéisearcha. Thairis sin, faoin Acht um Chrannchur Náisiúnta 1986, ní mór faomhadh an Aire Airgeadais a fháil do ghnóthaí oibríocha áirithe agus chuige sin coinnítear teagmháil leanúnach leis an Aire.

Tugann an Cathaoirleach aiseolas don Bhord ar cheisteanna a thógann na scairshealbhóirí leis. Is gnách leis na Stiúrthóirí uile freastal ar an gCruinniú Cinnbhliana [CCB] agus tugtar cuireadh do na scairshealbhóirí ceisteanna a chur le linn an chruinnithe agus casadh ar na Stiúrthóirí nuair a bhíonn deireadh leis na himeachtaí foirmiúla.

### Rialú Inmheánach

Tá próiseas leanúnach ann chun na rioscaí suntasacha, a gcaitheann an Comhlacht aghaidh a thabhairt orthu, a aithint, a mheasúnú agus a bhainistiú. Tá an próiseas seo bunaithe ar Threoracha an Chomhchóid do stiúrthóirí a d'eisigh Institiúid na gCuntasóiri Caire i Sasana agus sa Bhreatain Bheag (Treasurer Turnbull). Athbhreithníonn na Stiúrthóirí é ó am go chéile agus bhí feidhm leo le linn na tréimhse cuntasáiochta suasa go dtí an dáta ar ar faomhadh na ráitis airgeadais.

Faoi réir na treorach a thugann coiste Turnbull, tá na Stiúrthóirí freagrach as córas rialaithe inmheánaigh an Chomhlachta. Ba chóir dóibh polasaithe cuí ar rialú inmheánach a shocrú, deimhniú a lorg go rialta a shásóidh iad go bhfuil an córas ag feidhmiú go héifeachtach agus ní mór dóibh a bheith sásta go bhfuil an córas rialaithe inmheánaigh éifeachtach chun rioscaí a bhainistiú ar an dóigh a faomhadh. Ceaptar córas mar seo chun rioscaí gnó a bhainistiú seachas fáil réidh leo agus ní thig leis ach barántas réasúnta, seachas barántas iomlán, a thabhairt in aghaidh aon mhíráiteas nó caillteanas ábhartha.

Lean na Stiúrthóirí de bheith ag athbhreithniú éifeacht chórás rialaithe airgeadais agus neamh-airgeadais an Chomhlachta, ina measc rialúcháin oibríoch agus géilliúntais, bainistíocht rioscaí agus socrúithe rialaithe ardleibhéal an Chomhlachta. Mar chuid den athbhreithniú seo rinneadh meastóireacht ar rialúcháin inmheánacha na bainistíocha, ar dheimhnithe ón mbainistíocht go leantar den rialú, ar thuairiscí ón iniúchóir inmheánach agus ar thuairiscí ón iniúchóir seachtrach ar chúrsaí a ithníodh agus an obair reachtúil iniúchóireachta ar bun.

Tá an Comhlacht den tuairim gur eochair-ghníomhaíocht de chuid na bainistíocha é bainistiú cáiréiseach a dhéanamh ar rioscaí. Buneilimint i ngach gníomhaíocht é rioscaí gnó a bhainistiú chun deiseanna a thapú. Déantar é seo trí úsáid a bhaint as frámaíocht shimplí sholúbtha a chruthaíonn bealach buan agus seasmhach chun luachanna an Chomhlachta a chur i bhfeidhm. Ba chóir go mbeadh na rioscaí gnó seo, bíofa ina rioscaí straitéisearcha, oibríocha, dea-cháile, airgeadais nó timpeallachta, intuigthe agus sofheicthe. I ngach cúnis, is é an comhthéacs gnó a shocraíonn leibhéal inghlachta rialú rioscaí agus rialúcháin.

## Report of the Directors

Management is responsible for the identification and evaluation of significant risks and for the design and implementation of appropriate internal controls. These risks are assessed on an ongoing basis and are derived from a variety of external and internal sources. Management reports regularly to the Board on the key risks inherent in the business and on the way in which these risks are managed. Management also reports to the Board on any significant changes in the Company's business and on any risks associated with such changes. The process used to identify and manage key risks is an integral part of the internal control environment.

The key procedures which the Directors have established with a view to providing effective internal control are as follows:

- A clear focus on business objectives as determined by the Board after consideration of the statutory responsibilities and risk profile of the Company's business.
- A defined organisational structure with clear lines of responsibility, delegation of authority and segregation of duties designed to foster a beneficial control environment.
- A risk management process which considers the strategy and development of the business in the context of the annual budget process when financial plans and performance targets are set and reviewed by the Board in light of the Company's overall objectives.
- A report and control system which produces a comprehensive set of financial reports. The annual budget is approved by the Board. Key financial statistics are monitored by management on a daily basis. Actual results are reported monthly against budget and any significant adverse variances are examined and remedial action taken.
- Control procedures – comprehensive procedures manuals are maintained by the Company in respect of all its main activities. In particular, there are clearly defined limits and procedures for financial expenditure, including procurement and capital expenditure, and for all draw operations.
- Monitoring system – compliance with control objectives is monitored on an ongoing basis by management. The control system is also monitored by internal audit whose work is focused on the areas of greatest risk to the Company.

The Company has procedures to ensure that appropriate arrangements are in place for employees to be able to raise, in confidence, matters of possible impropriety, with suitable subsequent follow-up action. Reporting channels have been created whereby perceived wrongdoing may be reported orally and via post, telephone and email, anonymously if preferred.

## Tuarascáil na Stiúrthóirí

Tuairiscíonn ar bhanistíocht go rialta don Bhord ar na príomh-rioscaí a bhaineann leis an gngó agus ar an tsíl ina ndéantar bainistiú ar na rioscaí. Tuairiscíonn an bhanistíocht don Bhord freisin ar athruithe suntasacha i ngnóthaí an Chomhlachta agus aon rioscaí a eascraíonn as na hathruithe seo. Dlúthchuid den timpeallacht inmheánach rialaithe é an próiseas a úsáidtear chun na príomh-rioscaí a aithint agus a bhanistiú.

Seo a leanas na príomh-ghnáthaimh a cheap na Stiúrthóirí chun rialú inmheánach éifeachtach a chinntí:

- Fócas grinn ar na cuspóirí gnó, mar atá leagtha amach ag an mBord, tar éis na freagrachtaí reachtúla is príofíl riosca an Chomhlachta a thabhairt san áireamh.
- Struchtúr sainithe eagraíochta le línte soiléire freagrachta, tarmligeán údarás agus dealú dualgas a cheapadh chun timpeallacht tairbheach rialaithe a chothú.

- Córás faireacháin – déanann bainistíocht an Chomhlachta faireachán ar chomhlíonadh na gcuspóirí rialaithe ar bhonn leanúnach. Déantar faireachán ar an gcórás rialaithe freisin trí iníúchadh inmheánach a dhéanamh ar na gnéithe úd is mó riosca don Chomhlacht.

Tá gnáthaimh i bhfeidhm ag an gComhlacht a chinntíonn gur féidir le fostaithe ceisteanna faoi aon iompar míchuí, a fhéadfadh a bheith ann, a ardú faoi dhiscréid agus go leantar an cheist ansin ar bhealach cuí. Tá bealaí tuairiscithe ceaptha trínr Féidir aon iompar míchuí, a mheastar a bheith ann, a thuairisciú de bhéal, trí an bpost, thar an teileafón nó i ríomhphost, agus é sin gan ainm a thabhairt más fearr sin.

- determines the pay structures and terms and conditions of other senior personnel;
- takes all decisions related to pay and pay related matters; and
- considers any other matters which it deems to be relevant to the foregoing.

The disclosures made in these financial statements relating to Directors' emoluments and pension information are those required under the Irish Companies Acts, 1963 to 2009.

### The Audit Committee

During the year, the Audit Committee comprised James Hyland, Niamh McGowan (until 5 November, 2010), Barbara Patton (from 5 November, 2010) and Micheál Ó'Muircheartaigh. James Hyland acts as Chairman of the Committee. All the members of the Committee are independent non-executive Directors.

## Report of the Directors

Under its terms of reference, the Audit Committee monitors the integrity of the Company's financial statements. The Committee is responsible for monitoring the effectiveness of the external audit process and making recommendations to the Board in relation to the appointment, re-appointment and remuneration of the external auditors. It is responsible for ensuring that an appropriate relationship between the Company and the external auditors is maintained, including reviewing non-audit services and fees. As a result of regulatory or similar requirements, it is necessary to employ the Company's external auditors for certain audit related and non-audit services. In order to maintain the independence of the external auditors, the Committee has determined policies as to what audit related and non-audit services can be provided by the Company's external auditors and the approval process related to these services. In particular, the Board considers it appropriate that independent observer and draw related services, which are the principal constituent of audit related fees paid, be performed by the external auditors. Under these policies, work of a consultancy nature will not be offered to the external auditors unless there are clear efficiencies and value added benefits to the Company while ensuring that the objectivity and independence of the external auditors is maintained. The Committee monitors the level of fees paid to the external auditors.

The Committee reviews annually the Company's systems of internal control and the processes for monitoring and evaluating the risks facing the Company.

The Committee meets with management, as well as privately with the external auditors.

In 2010, the Committee discharged its responsibilities by:

- reviewing the Company's draft financial statements prior to Board approval and meeting and reviewing with the external auditors their reports thereon;
- reviewing the appropriateness of the Company's accounting policies;
- reviewing the potential impact on the Company's financial statements of significant matters;
- reviewing the resources of internal audit, approving the internal audit plans, reviewing internal audit reports and dealing with control issues raised by the internal auditors;
- reviewing and approving the audit fee and reviewing non-audit fees payable to the Company's external auditors;
- reviewing the external auditors' plan for the audit of the Company's financial statements, confirmations of auditor independence and the proposed audit fee, and approving the terms of engagement for the audit;
- considering the adequacy of the Company's system of risk identification and assessment;
- reviewing an annual report on the Company's systems of internal control and its effectiveness, reporting to the Board on the results of the review and receiving regular updates on key risk areas of financial control;

## Report of the Directors

### Nomination Committee

As all the authority regarding the appointment of Directors is vested with the Minister for Finance, the matter of constituting a nomination committee is not required to be considered by the Board.

### Compliance statement

The Board has developed its corporate governance policy so as to give effect to the Code of Practice for the Governance of State Bodies issued by the Department of Finance and to apply as appropriate the relevant main and supporting principles of good governance in the Combined Code issued by the Financial Reporting Council in the UK.

The Directors confirm that the Company has been in compliance with the Code of Best Practice for the Governance of State Bodies and the relevant main and supporting principles of the Combined Code throughout the financial year under review, with the exception of a number of areas noted above where voluntary compliance with the Combined Code is not considered necessary for the Company given the manner of appointment of Directors, the shareholding structure of the Company and existing Board procedures.

### Going Concern

The Directors have reviewed the Company's business plan and other relevant information including the terms of the licence granted by the Minister for Finance to the Company for the operation of the National Lottery until 31 December, 2011. On that basis, the Directors have a reasonable expectation that the Company will continue in operational existence for the foreseeable future. For this reason, the Directors continue to adopt the going concern basis in preparing the financial statements.

### Accounting Records

## Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the Company's financial statements.

### 1. Basis of Accounting

The financial statements are prepared under the historical cost convention in accordance with applicable law and Irish Generally Accepted Accounting Practice which includes compliance with the financial reporting standards of the UK Accounting Standards Board as promulgated by The Institute of Chartered Accountants in Ireland.

### 2. Turnover

Turnover from the sale of National Lottery tickets is recognised as the tickets are sold, with adjustments being made for scratch card ticket stocks held by agents and for multi draw tickets/advance tickets.

All turnover is derived from and originates in Ireland.

### 3. Prizes

The prize structure complies with the requirements of Section 4(2) of the National Lottery Act, 1986 whereby, taking one year with another, not less than 40% of the total monies received by the Company in respect of the sale of National Lottery tickets shall be distributed in prizes. Prizes are provided for as revenue is recognised on the basis of the game's particular prize structure. Any difference between the total amount provided and the amounts actually distributed is included in Creditors in the balance sheet.

### 4. Advertising and Promotional Expenditure

Advertising and promotional expenditure is written off in full in the year in which the costs are incurred.

### 5. Leased Assets – Operating

Operating lease rentals are charged to the Profit and Loss Account on a straight line basis over the lease term.

### 6. Taxation

The Company is exempt from Corporation Tax under Section 220 Taxes Consolidation Act, 1997.

### 7. Fixed Assets – Tangible Assets

Tangible assets are shown as having no book value, as the total cost thereof to the Company is reimbursed out of the National Lottery Fund.

Accordingly, no depreciation is provided.

Under Section 17(1) (a) of the National Lottery Act, 1986, the Company holds these assets in trust for the State.

## Polasaithe Cuntasáiochta

### 1. Bunús na Cuntasáiochta

Ullmhaítear na ráitis airgeadais de réir dlíthe oiriúnacha na hÉireann agus na gCleachtas Cuntasáiochta, a bhfuil gnáth-ghlacadh leo in Éirinn, ar a áiritear cloí leis na caighdeán a d'eisigh an UK Accounting Standards Board ar thairisciú airgeadais agus a d'fhoilsigh Institiúid na gCuntasóirí Cairte in Éirinn.

### 2. Láimhdeachas

Aithnítear an láimhdeachas ó dhíolachán thicéid an Chranncuir Náisiúnta de réir mar a dhíoltar na ticéid agus déantar coigeartuithe don stoc ticéad scríobchártai a choinníonn na gníomhairí agus do thicéid/réamh-thicéid- ilchrannchuir.

As Éirinn a thagann agus is in Éirinn a fhaightear an láimhdeachas uile.

### 3. Duaiseanna

Tá an duais-struchtúr ag teacht le forálacha Alt 4(2) den Acht um Chranncuir Náisiúnta 1986. ## Accounting Policies

### 8. Fixed Assets – Financial Assets

Financial fixed assets are shown at cost less provisions for impairments in value. Income from financial fixed assets is recognised in the Profit and Loss Account in the year in which it is receivable.

### 9. Stocks

Stocks comprise scratch card ticket stocks and are valued at cost. Cost includes import duties, V.A.T. and transport costs. All unusable and obsolete stock is written off.

### 10. Foreign Currencies

Transactions denominated in foreign currencies are translated into Euro and recorded at the rate of exchange ruling at the date of the transaction. Monetary liabilities denominated in foreign currencies are translated into Euro at the rate of exchange ruling at the balance sheet date or at forward purchase contract rates where such contracts exist. All exchange differences are dealt with in the Profit and Loss Account.

### 11. Pensions

Pensions are provided to seconded staff under multi-employer defined benefit superannuation schemes which are administered by the Company's parent, An Post, and a defined contribution scheme. In relation to the defined contribution scheme, contributions are accrued and recognised in operating profit or loss in the period in which they are earned by the relevant staff.

Due to the seconded nature of staff, the Company is unable to identify its share of the underlying assets and liabilities in the defined benefit scheme which may be attributable to the Company on a consistent and reasonable basis. Because of this, as permitted by FRS 17, the defined benefit schemes are accounted for by the Company as if the schemes were defined contribution schemes.

### 16. Pensions

The pension entitlements of staff arise under a number of An Post externally funded defined benefit and defined contribution pension schemes, the assets of which are vested in independent trustees appointed by An Post for the sole benefit of employees and their dependants.

An Post operates multi-employer defined benefit schemes. Due to the seconded nature of staff, the Company is unable to identify the share of the underlying assets and liabilities in the schemes, which may be attributable to the Company, on a consistent and reasonable basis. Because of this, as permitted by FRS17, the schemes have been accounted for by the Company as if the schemes were defined contribution schemes.

The valuations of the An Post defined benefit schemes used for the purposes of the FRS17 disclosures have been based on the previous actuarial valuations carried out at 1 January, 2008, updated by the independent actuaries in accordance with FRS17 to assess the schemes' liabilities at 31 December, 2009. The schemes' assets were stated at their market value at that date. As disclosed in the 2009 Financial Statements, the net pension liabilities of the pension schemes at 31 December, 2009, the most recently available information, amounted to €403 million. At that date An Post had 9,730 permanent employees not including the 99 staff of An Post National Lottery Company.

The pension costs of the An Post defined benefit schemes are assessed in accordance with the advice of an independent professionally qualified actuary. The most recent actuarial valuations were carried out at 1 January, 2008, using the attained age method and disclosed that the assets of the schemes at that date were sufficient to cover more than 100% of the accrued liabilities after allowing for expected future increases in pensionable remuneration.

Contributions to the defined benefit schemes were at a rate of 14.4% (2009: 14.4%) of pensionable remuneration.

The actuarial valuations are not available for public inspection but the results of the valuations have been advised to members of the schemes.

Employer contributions to the defined contribution scheme are at rates varying between 5% and 9% of pensionable remuneration.

The total pension cost in respect of the Company for the year ended 31 December, 2010 was €896,000 (2009: €885,000).

An amount of €14,000 is included in accruals (2009: €10,000) representing contributions payable to An Post with respect to the pension schemes at 31 December, 2010.

### 19. Group Membership and Controlling Party

The Company is a subsidiary undertaking of An Post which holds 80% of the issued share capital.

The sole activity of the Company is the operation of the National Lottery under Licence from the Minister for Finance in accordance with the provisions of the National Lottery Act, 1986. The Licence expires on 31 December, 2011. The surplus generated each year is entirely attributable to the National Lottery Fund and, accordingly, the results of the Company are not consolidated within the An Post Group.

The Company was managed and controlled throughout the year by the Directors on behalf of An Post and the ultimate controlling party, the Minister for Finance.

### 20. Related Party Disclosures

In addition to the secondment of staff working in the Company, undertakings in the An Post Group provide the Company with management and delivery of services. Such services are carried out on an arm's length basis or, where appropriate, in accordance with the terms of the Licence granted by the Minister for Finance to the Company, to operate the National Lottery. An Post also provides agency services to the Company whereby An Post makes sales and pays prizes on behalf of the Company in accordance with the standard terms and conditions and remuneration structure common to all of the Company's agents.

Excluding staff costs (Note 6) and including the Management Fee, expenses for the year in respect of services provided by An Post Group undertakings to the Company amounted to €6,172,000 (2009: €6,346,000).

Amounts due to An Post are set out in Note 12 of the accounts.

The Company's parent, An Post, has agreed to guarantee the performance by the Company of its obligations under the Licence for the holding of the National Lottery granted by the Minister for Finance. An Post has provided the guarantee, the maximum liability of which amounts to €10 million, for the duration of the Licence.

### 21. Board Approval

The financial statements were approved by the Board of Directors on 22 February, 2011.
