



### ***Terms & Conditions for entry into the National Lottery Good Causes Awards 2024***

#### **1. Introduction**

All applicants to the National Lottery Good Causes Awards 2024 (an initiative of Premier Lotteries Ireland DAC (“PLI”) t/a The National Lottery) must agree and adhere to these Terms & Conditions.

By entering this competition, the applicant agrees to these Terms & Conditions.

#### **2. Entry**

The awards are open to every individual, club, charity, voluntary organisation or project that has received National Lottery funding in the calendar years 2019 to 2023 inclusive. Applications can be made by completing the relevant form online at [www.lottery.ie/goodcausesawards](http://www.lottery.ie/goodcausesawards) by 5.00pm on 4th of April 2024.

No purchase of any National Lottery product is necessary in order to enter.

#### **3. Eligibility Criteria**

The competition is open to any organisation, club, individual or projects that received funding in the calendar years 2019, 2020, 2021, 2022 & 2023, which are or have been part financed by National Lottery proceeds, from any of the following:

- **Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media:**
  - Funding received from Sport Ireland
  - Funding received through Sports Capital Programme Grants
  - Funding received from The Arts Council of Ireland
  - Irish Language Support Grants
- **Department of Rural and Community Development:**
  - Funding received from Senior Alert Schemes
  - Funding through the Scheme to Support National Organisations (SSNO)
- **Department of Housing, Local Government and Heritage:**

- Funding received from The Heritage Council of Ireland
- Housing Adaptation Grants
- **Department of Children, Equality, Disability, Integration and Youth**
  - Funding received from UBU Your Place Your Space grants, Youth Services Grant Scheme, Targeted Youth Funding Scheme and Youth Information Centre grants
- **Department of Health**
  - Funding received through the HSE National Lottery grant scheme

Applicants can check to see if they are eligible to enter the awards by visiting [www.lottery.ie/goodcausesawards](http://www.lottery.ie/goodcausesawards).

All entries will be checked against the National Lottery's database of Good Causes beneficiaries to ensure that they are eligible. If your name does not appear and you believe you received funding during these years, please email [goodcausesawards@lottery.ie](mailto:goodcausesawards@lottery.ie) and a member of our team will discuss with you.

Any individual entering whether on behalf of themselves or an organisation, club, or project must be over the age of eighteen (18) years. This does not exclude any organisation, clubs or projects that involve minors (under the age of eighteen) (18).

PLI, which operates the National Lottery, is not responsible for any incomplete, incomprehensible or misdirected entries. Such entries will be deemed to be void at the instance of the National Lottery.

#### **4. Categories**

There will be seven (7) overall categories for the National Finals of the Good Causes Awards.

The seven (7) categories are as follows:

- Sport. Winning through inclusion.
- Health & Wellbeing. Promoting healthier & happier communities.
- Arts & Culture. Celebrating Irish creativity.
- Heritage. Protect, preserve and promote.
- Youth Affairs. Nurturing Ireland's Next Generation.
- Community. Enriching the fabric of Irish life.
- Irish Language. An Grá Cainte.

#### **5. Competition Phases: County and National**

The competition has two (2) phases:

- County
- National

##### ***County Phase***

This phase is open to beneficiaries in any of the seven (7) categories of Sport, Health & Wellbeing, Arts & Culture, Heritage, Youth, Community & Irish Language who have received National Lottery Good Causes funding in any of the twenty-six (26) counties in the Republic of Ireland.

Due to its population density, what is the geographic region of County Dublin will be split into the following 3 areas -

- 1) Dublin City (Dublin City Council region)
- 2) Dublin North (Fingal County Council)
- 3) Dublin South (South County Dublin & Dun Laoghaire Rathdown Council regions)

To ensure fairness and equitable distribution, and in recognition of concentration and movement of population within the broader geographical region that is County Dublin Area, the National Lottery reserves the right to reallocate entries from any Dublin region to any other region within the geographical region that is County Dublin.

This will increase to twenty-eight (28) the number of regions for the County stage. This increases the total number of county winners as there is potential for seven (7) category winners from each of the twenty-eight (28) County regions.

In addition, the National Lottery reserves the right to permit a second entry per category from the Dublin City area to progress to the County Stage in recognition of the high proportional concentration of national Good Cause beneficiaries located in Dublin City.

The maximum total number of County winners for the National Lottery Good Causes Awards 2024 is one hundred and ninety-six (196).

### ***National Phase***

Each winning Good Cause in the County phase will then automatically go forward for inclusion in the National Phase of the competition.

Within each category, each application will be marked out of ten (10) by each judge in our National judging panel, and the total score will determine the winner within each category.

On completion of the National Final stage, there will be five (5) winners chosen in each of the seven (7) categories i.e., 35 Good Causes who will progress to the National Finals.

The 35 Good Causes finalists going forward to the National Finals will be announced w/c 17<sup>th</sup> June 2024.

## **HERO OF THE YEAR AWARD**

The “HERO OF THE YEAR” award will be presented to a volunteer or employee of one of the national finalist Good Cause beneficiaries who goes over and above to make a difference.

Each of the thirty-five (35) National Finalists is invited to nominate one person for this award. This award presents a wonderful opportunity to recognise and celebrate the impact made.

The Hero of the Year winner will be announced at the National Lottery Good Causes Awards on Saturday 12<sup>th</sup> October at Killashee Hotel, Naas, Co. Kildare. The winner will receive a certificate and a prize of €5,000, to spend as they wish.

### ***National Finals Judging phase***

Each of the thirty-five (35) finalists will be required to give a five-minute presentation on the impact their Good Cause has had on their communities followed by a ten-minute Q&A with the National Finals judging panel.

Up to two (2) members of the Good Cause may participate in the presentation.

Presentations to the judging panel may be delivered in person at National Lottery Headquarters or remotely across two (2) dates in September 2024. Dates will be determined by the National Lottery.

### ***Gala Awards Event***

The winners of the National Finals will be publicly announced at a black-tie awards dinner on Saturday 12<sup>th</sup> October 2024. Five (5) representatives from each National Finalist will be invited to the awards dinner.

There will be an overall National winner in each of the seven (7) categories.

Of the seven (7) category award winners, one (1) will be awarded “National Lottery Good Cause of the Year 2024”.

## **6. Assessment Criteria**

The scoring criteria used by the judging panel to assess each application is as follows:

**Q1** Tell us briefly about you, your community project, organisation or club?

Assessment Criteria:

First Impressions of the organisation, club or individual - How well do they engage you in how they tell their story?

**Q2** How did your sport, project, organisation, or community benefit from National Lottery Good Causes funding and what did it enable the project to do differently, new, and what impact had it on the project or wider community?

Assessment Criteria:

1. Scale of the Impact (this is not necessarily the number of people they support, it's depth of the impact that they make to those they serve).
2. Difference to people's lives - how does the work of this organisation impact on the people they support?
3. How innovative is this organisation? Are they doing something really different and unique?
4. Impact of the Good Causes Funding - how did the Good Causes funding enhance their ability to deliver particular projects/services?

**Q3:** Tell us how your organisation fosters a welcome for all and/or promotes sustainability?

Assessment Criteria:

Are they clearly showing a commitment to Sustainability by reducing environmental impact and/or promoting and fostering an inclusive environment that ensures equal opportunities for all, regardless of gender, race, ethnicity, or other diverse characteristics.

**Q4** Please highlight to us one (1) standout moment or story that you are most proud of, that demonstrates why this project/organisation should win this award?

Assessment Criteria:

The X Factor - How does this organisation, its people or its activities stand out from the crowd? How different are they from other organisations?

## **Hero of the Year**

NOTE: Only the 35 National Finalists are invited to complete this nomination process.

**Q1** Name of the nominee and the role they play in the organisation

**Q2** Tell us why they should be Hero of the Year

Assessment Criteria:

How does this nominee make a real difference in their group/community?

How does this Hero of the Year nominee get the best out of others?

**Q3** What three words describe this person?

Assessment Criteria:

Do these three words demonstrate outstanding 'hero' qualities that sets them apart from others?

## **7. Prizes**

All prize monies are the property of the winning Good Cause and must be reinvested into the Good Cause.

The prize structure for the competition will be broken down as follows:

All Finalists who progress to the National Finals will receive the sum of €1,000 which is intended for the benefit of the Good Cause beneficiary. This may also be used to off-set any costs of participating in the competition e.g. travel, accommodation etc.

## **8. Competition Rules**

All decisions made by the judging panel in each of the two (2) phases (County and National) will be final in all circumstances.

All applicants must apply under the relevant category and in the location where the group, organisation, club, or project is located. Any queries about the jurisdiction of the project can be detailed on the application form.

PLI reserves the right to reassign an applicant to a different category than stated on their application should (i) the relevant Good Cause have received funding in more than one (1) category, or (ii) should there be an error on the application from a Good Cause.

The National Lottery reserves the right to undertake a due diligence process on any/all finalists prior to announcing winners at the National Finals.

Canvassing by phone, in person or by a form of digital communication (e.g., email or social media contact) is strictly prohibited and is likely to result in an application being excluded from the competition at the instance of the National Lottery.

## **9. Judging Panel and Timeline**

The judging panel for this competition will be chaired by one (1) independent judge. The independent judge will be joined by other judges from varying disciplines for each different phase of the competition as outlined below:

- For the **County Phase** of the competition, the County winners will be determined by a team of experienced National Lottery staff volunteers. Each County winner will be ratified by the Chair, who will be joined by a senior representative from National Lottery. This judging process will take place from 8<sup>th</sup> – 29<sup>th</sup> April 2024. Subject to regulatory approval, announcement of the County winners is expected w/c 20<sup>th</sup> May 2024
- For the **National Phase** of the competition, the judging panel will consist of five (5) people. The independent judge will be joined by one (1) National Lottery representative, an independent representative from the retail sector and two (2) representatives from any (1) of the areas of sport, arts & culture, heritage, health & wellbeing, community, and youth affairs.
- This selection process will take place in the National Lottery offices or online once the County winners are announced. (Up to) one hundred and ninety-six (196) county winners will be shortlisted to five (5) National finalists in each of the seven (7) categories.
- For the **Final Phase** of the competition to determine the overall winners, the judging panel will consist of six (6) people - the Chair, two (2) senior representative from the National Lottery, an independent representative from the retail sector and two (2) representatives from any one (1) of the areas of sport, arts & culture, heritage, health & wellbeing, community and youth affairs. Over the course of two (2) to three (3) days, each of the 35 finalists will make a five-minute presentation and have a ten-minute Q&A with the judging panel. Each finalist will be scored independently by each judge and scores will be amalgamated to confirm results.

At application stage, all winners of will agree and consent to have the name of the Good Cause published on the National Lottery website ([www.lottery.ie](http://www.lottery.ie)); official social media channels including, but not limited to, Facebook, Twitter and Instagram after the winners are announced.

Representatives from all winning Good Causes must make themselves available to attend photocalls when required. Further publicity commitments, such as National Finals photocall, and the participation in a short video (for each National Finals winner) will be used by the National Lottery to promote the National Final online and on social media channels.
